1.5	Section 1. CITY OF NORTH MANKATO; FOOD AND BEVERAGE TAX
1.6	AUTHORIZED.
1.7	Subdivision 1. Food and beverage tax authorized. Notwithstanding Minnesota Statutes
1.8	section 477A.016, or any ordinance, city charter, or other provision of law, the city of North
1.9	Mankato may, by ordinance, impose a sales tax of up to one percent on the gross receipts
1.10	on all sales of food and beverages by a restaurant or place of refreshment, as defined by
1.11	resolution of the city, that are located within the city. For purposes of this section, "food
