The bill was read for the first time and referred to the Committee on Environment and Natural Resources Policy and Finance

1.1 A bill for an act  
1.2 relating to capital investment; appropriating money for a safe harbor on Lake  
1.3 Superior at Two Harbors; authorizing the sale and issuance of state bonds.

1.4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.5 Section 1. **SAFE HARBOR; TWO HARBORS.**

1.6 Subdivision 1. **Appropriation.** \$750,000 is appropriated from the bond proceeds fund  
1.7 to the commissioner of natural resources for a grant to the city of Two Harbors to design  
1.8 and engineer a small-craft safe harbor on Agate Bay in Two Harbors.

1.9 Subd. 2. **Bond sale.** To provide the money appropriated in this section from the bond  
1.10 proceeds fund, the commissioner of management and budget shall sell and issue bonds of  
1.11 the state in an amount up to \$750,000 in the manner, upon the terms, and with the effect  
1.12 prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the Minnesota  
1.13 Constitution, article XI, sections 4 to 7.

1.14 **EFFECTIVE DATE.** This section is effective the day following final enactment.
