1.5	Section 1. WINONA; PUBLIC SAFETY FACILITY.
1.6	Subdivision 1. Appropriation. \$21,000,000 is appropriated from the bond proceeds
1.7	fund to the commissioner of public safety for a grant to the city of Winona to acquire real
1.8	property for a site, and to predesign, design, construct, furnish, and equip a regional public
1.9	safety center to collocate police, fire, and other public safety entities.
