Subdivision 1. **Program establishment.** The commissioner shall establish a program supporting coordinated, aligned educational partnerships as specified in this section, for a comprehensive network of evidence-based support services designed to close opportunity gaps by improving educational and developmental outcomes of children and their families within defined geographic areas experiencing poverty and impediments to economic viability.

Subd. 2. Administration; design. (a) Subject to the requirements in this section, the commissioner shall establish and make publicly available: program requirements, an application process and timeline for each tier of grants specified in subdivision 4, criteria for evaluation of applications, and a grant awards process. Requirements and processes must minimize administrative costs, minimize burdens for applicants and grant recipients, and provide a framework that permits flexibility in program design and implementation among grant recipients.

(b) In establishing and designing the program, the commissioner shall take into consideration alignment with programs implemented or proposed by organizations in Minnesota that:
