BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: 1.4 Section 1. MINNESOTA ZOOLOGICAL GARDEN. 1.5 Subdivision 1. Appropriation. \$24,000,000 is appropriated from the bond proceeds 1.6 fund to the Minnesota Zoological Board for the purposes specified in this section. 1.7 Subd. 2. Animal hospital renovation. \$5,000,000 of this appropriation is to design, 18 renovate, construct, furnish, and equip the animal hospital at the Minnesota Zoological 1.9 Garden. 1.10 Subd. 3. Reopen the Nocturnal Trail. \$4,000,000 of this appropriation is to design, 1.11 renovate, construct, furnish, and equip the closed portion of the Nocturnal Trail. 1.12 Subd. 4. Asset preservation. \$15,000,000 of this appropriation is for capital asset 1.13 preservation improvements and betterments to infrastructure and exhibits at the Minnesota 1.14 Zoological Garden, to be spent in accordance with Minnesota Statutes, section 16B.307. 1.15 Notwithstanding the specified uses of money under Minnesota Statutes, section 16B.307, 1.16 the board may use this appropriation to replace buildings that are in poor condition, outdated, 1.17 and no longer support the work of the Minnesota Zoological Garden site. A portion of this 1.18 appropriation must be used to replace the Lakeside Plaza. 1.19 Subd. 5. **Bond sale.** To provide the money appropriated in this section from the bond 1.20 proceeds fund, the commissioner of management and budget shall sell and issue bonds of 1.21 the state in an amount up to \$24,000,000 in the manner, upon the terms, and with the effect 1.22
