Minnesota Statutes 2014, section 97A.045, subdivision 7, is amended to read: 18 Subd. 7. Duty to encourage stamp design and purchases. (a) The commissioner 1.9 shall encourage the purchase of: 1.10 (1) Minnesota migratory waterfowl stamps by nonhunters interested in migratory 1 11 waterfowl preservation and habitat development; 1.12 (2) pheasant stamps by persons interested in pheasant habitat improvement; 1.13 (3) trout and salmon stamps by persons interested in trout and salmon stream and 1.14 1.15 lake improvement; and (4) turkey stamps by persons interested in stamp collecting; and 1.16 (5) (4) walleye stamps by persons interested in walleye stocking and stamp collecting. 1 17 (b) The commissioner shall make rules governing contests for selecting a design for 1 18 each stamp, including those stamps not required to be in possession while taking game or 1.19 fish. 3.9 identification number or stamp validation, does not entitle a licensee to exercise the rights
3.10 or privileges conferred by a license.

(d) A license issued electronically and not immediately provided to the licensee shall 3.11 be mailed to the licensee within 30 days of purchase of the license. A pictorial migratory 3.12 waterfowl, pheasant, trout and salmon, or walleye stamp shall be provided to the licensee 3.13 after purchase of a stamp validation only if the licensee pays an additional fee that covers 3.14 the costs of producing and mailing a pictorial stamp. A pictorial turkey stamp may be 3.15 purchased for a fee that covers the costs of producing and mailing the pictorial stamp. 3.16 Notwithstanding section 16A.1283, the commissioner may, by written order published in 3.17 the State Register, establish fees for providing the pictorial stamps. The fees must be set in 3.18 an amount that does not recover significantly more or less than the cost of producing and 3.19 mailing the stamps. APPENDIX Repealed Minnesota Statutes: 16-6856

97A.075 USE OF LICENSE REVENUES.

Subd. 5. **Turkey account.** (a) \$4.50 from each turkey license sold, except youth licenses under section 97A.475, subdivision 2, clause (4), and subdivision 3, clause (7), must be credited to the wild turkey management account and is appropriated to the commissioner only for:

(1) the development, restoration, and maintenance of suitable habitat for wild turkeys on public and private land including forest stand improvement and establishment of nesting cover, winter roost area, and reliable food sources;

(2) acquisitions of, or easements on, critical wild turkey habitat;

(3) reimbursement of expenditures to provide wild turkey habitat on public and private land;

(4) trapping and transplantation of wild turkeys; and

(5) the promotion of turkey habitat development and maintenance, population surveys and monitoring, and research.

(b) Money in the account may not be used for:

(1) costs unless they are directly related to a specific parcel of land under paragraph (a), clauses (1) to (3), a specific trap and transplant project under paragraph (a), clause (4), or to specific promotional or evaluative activities under paragraph (a), clause (5); or

(2) any permanent personnel costs.
