

Deposit draft of said road and accurate draft of the location of the road, a copy of which shall be deposited with the register of deeds of said county.

Who not to pay expenses of location of said road
 SEC. 4. That neither the State of Minnesota, the county of Mower or any town through which the located line of road may pass, shall ever be liable for any expense whatever, accruing from the location of said road.

Act, when to take effect
 SEC. 5. This Act shall take effect from and after its passage.

CHAPTER XV.

An Act to Provide for Laying out a State Road from Sauk Rapids to Fortuna.

- SECTION 1. Commissioners appointed.
 2. When and where to meet—to fill vacancies.
 3. To designate when to begin operations.
 4. Expenses to be paid by the counties through which said road passes.
 5. Act—when to take effect.

Be it enacted by the Legislature of the State of Minnesota:

Commissioners appointed

SEC. 1. That Charles A. Gillman, William Smith and Adolph Munch be, and they are hereby appointed commissioners to locate and mark a State road, commencing at Sauk Rapids in Benton county, and from thence on the most direct and feasible route to intersect the road located from St. Paul on the south side of Snake River to Lake Superior, at such point as the said commissioners may deem best.

When and where to meet—to fill vacancies

SEC. 2. That said commissioners shall meet at Sauk Rapids, on the first of October next, and in case any of the commissioners appointed by this Act neglect or refuse to act as provided by this Act, the others shall appoint some reliable person or persons to fill such vacancy.

To designate when to begin operations

SEC. 3. That at the first meeting of said commissioners, they shall designate the time when they will commence the laying out said road, and may adjourn from time to time as may in their opinion be necessary.

SEC. 4. That the necessary expenses incurred for lay-

ing out said road, shall be paid by the counties through which said road shall pass, in proportion to the length of said road in such counties, the amount to be paid by each county respectively, to be assessed by the commissioners who shall lay out and mark said road: Expenses to be paid by counties through which said road passes

SEC. 5. This Act shall take effect and be in force from and after its passage. Act, when to take effect

CHAPTER XVI.

An Act to Provide for the Location and Construction of a State Road from the City of Saint Paul in Ramsey County, to the Town of Owatonna in Steele County.

- SECTION 1. Commissioners appointed—who to fill vacancies in case of neglect to serve.
 2. When and where said Commissioners to meet—to file plat of road.
 3. Who to pay expenses.
 4. Width of road—counties through which road passes to be at no expense.
 5. Act—when to take effect.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That Peter Berkey, William Branch, and Charles N. Mackubin are hereby appointed commissioners to survey and locate a State road commencing at some point on the west bank of the Mississippi River opposite Saint Paul, to be selected by said commissioners or a majority of them; thence running by the shortest and best route to the town of Owatonna in Steele county, with a branch to Lakeville in the county of Dakota, and to that end the said commissioners are authorized to enter upon and cross the lands of any party or parties, and to take any lands necessary to be used for such road, upon first paying compensation therefor in the manner prescribed by law, in cases where roads are laid out and opened by town supervisors, and if any one of said commissioners shall neglect or refuse to serve, the judge of the district Commissioners appointed—who to fill vacancies
