SEC. 3. This act shall take effect and be in force from and after its passage.

## CHAPTER CVI.

### AN ACT TO APPROPRIATE MONEY FOR THE MAINTENANCE OF SOLDIERS' ORPHANS IN THIS STATE;

*Be it enacted by the Legislature of the State of Minnesota :*

Appropriation for soldier's orphans.

SECTION 1. The sum of sixteen thousand dollars (\$16,000) or so much thereof as may be necessary, is hereby appropriated out of any moneys in the treasury belonging to the state institutions fund, not otherwise appropriated, for the maintenance of the soldiers' orphans of this state.

When act to take effect.

SEC. 2. This act shall take effect and be in force from and after its passage.

## CHAPTER CVII.

### AN ACT TO APPROPRIATE MONEY FOR THE SUPPORT OF THE INDIGENT INSANE.

*Be it enacted by the Legislature of the State of Minnesota :*

Appropriation for hospital for insane.

SECTION 1. That the sum of seventy thousand five hundred dollars, or so much thereof as may be necessary, is hereby appropriated for the current expenses of the Minnesota hospital for insane, the same to be paid on warrants drawn by the president and countersigned by the secretary of the board of trustees

of that institution, and that on the presentation of such warrants on the state auditor, it shall be his duty to draw warrants on the state treasurer for like amounts. Such money to be expended under the direction of the board of trustees of the Minnesota hospital for insane. *Provided*, That the sum herein appropriated shall be drawn monthly in advance upon the estimated expenses for said institution. How drawn.

SEC. 2. This act shall take effect and be in force from and after its passage. When act to take effect.

### CHAPTER CVIII.

#### AN ACT TO APPROPRIATE MONEY FOR THE RELIEF OF DESTITUTE IMMIGRANTS.

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. There is hereby appropriated one thousand dollars from the general revenue fund for the relief of destitute immigrants, to be disbursed upon the orders of the governor. To be expended under direction of the Governor.

SEC. 2. This act shall take effect and be in force from and after its passage. When act to take effect.

### CHAPTER CIX.

#### AN ACT APPROPRIATING MONEYS FOR THE LEGISLATIVE EXPENSES OF THE PRESENT SESSION OF THE STATE OF MINNESOTA.

SECTION 1. That the sum of sixty-five thousand dollars, or so much thereof as may be necessary, be appropriated for the payment of salary, mileage and other expenses of the members and officers of the legislature during the present session. Legislative expenses.

SEC. 2. This act shall take effect and be in force from and after its passage. When act to take effect.

Approved January 13, 1876.
