

section thirty-three, town one hundred and four, range six west, all that part of the northeast quarter of the southwest quarter of section thirty-three, town one hundred and four, range six west, lying north of Elm street, in Mons. Anderson's addition to the village of Houston, the northeast quarter of section thirty-two, town one hundred and four, range six (6) west, the northeast quarter of section four, town one hundred and three, range 6 west, the east half of the northwest quarter of section four, town one hundred and three, range six west, and seven (7) acres off the east-side of the northwest quarter of the northwest quarter of section four, town one hundred and three (103), range six west.

SEC. 2. This act shall be in force from and after its passage.

CHAPTER X.

AN ACT TO INCORPORATE THE VILLAGE OF MINNESOTA LAKE.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the following described territory, to-wit: Commencing at the center of section thirty-three (33) in township number one hundred and five (105), north of range twenty-five (25) west, in the county of Blue Earth and state of Minnesota, running thence east, following the quarter section line, to the east line of section number thirty-four (34), thence south following the section line to the county line between the counties of Blue Earth and Faribault, thence east following said county line, to the quarter section post between sections two (2) in township one hundred and four (104), range twenty-five (25) and thirty-five (35), in township one hundred and five in said range, thence south following the quarter section line to the center of section fourteen (14), township number one hundred and four (104) north of range twenty-five (25) west in the county of Faribault, thence west following the quarter section line to the west line of section number sixteen (16), township number one hundred and four (104), north of range twenty-five (25) west, thence north following the section line to the county line between the counties of Blue Earth and Faribault, thence east following the county line to the quarter post between sections four (4) and thirty-three (33), thence north following the quarter section line to the place of beginning. That the same be and is hereby set apart for incorporation, and incorporated as a village under the corporate name and style of the village of Minnesota Lake to be organized pursuant to chapter one hundred and thirty-nine (139) of the general laws of 1875.

SEC. 2. That N. J. Krimer, W. Lambie, Chancy Barber, S. T. Barns and C. W. Apley, residents of the territory to be incorporated

be and are hereby designated to give notice of and for a meeting of the legal voters of said village and elect officers pursuant to said chapter one hundred and thirty-nine.

SEC. 3. The village council shall on or before the first day of September in each year certify and return to the auditor of the county in which any lot or lots or parts of lots, or parcels of land within said village are situate, the amount of taxes levied and assessments made by said council, and shall also certify and return to the auditor of the proper county the names of all owners of personal property residing in or owning personal property within said village subject to taxation thereon for village purposes.

SEC. 4. All warrants, writs, and processes of every nature issued by the justice of the peace of said village shall be directed to the constable of said village, or to the sheriff or any constable of the counties of Faribault and Blue Earth, and may be executed or served by the constable of said village or the sheriff or any constable of either of said counties; and for such purpose said constables, sheriffs and constables shall have and possess the power and authority which by the general laws of the state they have and possess in the execution or service of warrants, writs and other processes issued by justices of the peace elected under such general laws.

SEC. 5. That this act shall take effect and be in force from and after its passage.

CHAPTER XI.

AN ACT TO INCORPORATE THE VILLAGE OF CAMBRIDGE CITY,
IN THE COUNTY OF ISANTI, UNDER THE GENERAL LAW OF
EIGHTEEN HUNDRED AND SEVENTY-FIVE.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That the following described territory in the county of Isanti, to wit: The southwest quarter of section twenty-eight, south-east quarter of section twenty-nine, east half of northeast quarter, and lots one, two, three, four, five and six, and southeast quarter of section thirty-two; and the west half of section thirty-three of township thirty-six north, range twenty-three west, be and the same is hereby incorporated as the village of Cambridge City.

SEC. 2. That Thomas C. White; E. T. Flemming and J. R. De-Cousens are hereby designated as commissioners to post notices of the first election in said village.

SEC. 3. That upon organization as directed in chapter one hundred and thirty-nine of general laws of eighteen hundred and seventy-five, the said territory shall constitute the village of Cambridge City,
