## CHAPTER CV.

AN ACT TO CHANGE THE BOUNDARIES OF CERTAIN SCHOOL DISTRICTS IN THE COUNTY OF FARIBAULT.

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. That the northeast quarter of section one (1), township one hundred and three (103) north, of range twenty-eight (28) west, being a portion of Faribault county, be and the same is hereby detached from independent school district number seven (7), and attached to school district number thirteen, of the said county of Faribault.

SEC. 2. This act shall take effect and be in force from and after its passage.

## CHAPTER CVI.

AN ACT AUTHORIZING THE COUNTY COMMISSIONERS OF ANOKA COUNTY, TO ESTABLISH AND DEFINE THE BOUNDARIES OF THE SEVERAL SCHOOL DISTRICTS IN ANOKA COUNTY.

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. The county commissioners of Anoka county, are hereby authorized to establish and define the boundaries of the several school districts in Anoka county.

SEC. 2. The county commissioners of said county, shall appoint a time and place at which they will determine said boundaries, and shall post notice thereof, (setting forth the object of meeting, and the time and place at which it will be held), in three of the most public places in

said county, and cause a copy thereof to be filed with or addressed by mail to the clerk of each school district in said county, at least ten days before the time appointed for such meeting.

SEC. 3. At the time and place appointed for such meeting, the commissioners shall proceed to establish and define the boundaries of the several school districts in Anoka county. Where no cause for change is shown, they shall define and establish the boundaries as they are now supposed to exist. They shall also hear anything which may be said by interested parties, for or against any change in present boundaries; and when cause is shown shall make such change or changes in present boundaries as they shall deem for the best interests of the community; at the conclusion of the meeting, which may be adjourned from time to time, they shall cause to be entered in a book, (especially for that purpose), their decision—which shall be in the form of orders, one for each school district, particularly describing the boundaries thereof, signed by the chairman, and attested by the auditor, who shall cause a copy thereof to be filed with or addressed by mail to the clerk of district therein described.

SEC. 4. This act shall take effect and be in force from and after its passage.

## CHAPTER CVII.

AN ACT TO AUTHORIZE SCHOOL DISTRICT NUMBER THREE, IN THE COUNTY OF LINCOLN, TO ISSUE BONDS.

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. That the trustees of school district number three, in the county of Lincoln, are hereby authorized to issue the bonds of said district to the amount of one thousand dollars, with coupons attached, after the manner and conditions prescribed and authorized by chapter one of general laws of 1873.

SEC. 2. Such bonds shall be used and applied for payment of the present indebtedness of said district and for no other purpose.

SEC. 3. This act shall take effect and be in force from and after its passage.
