

## CHAPTER CXVIII.

AN ACT TO AUTHOIZE THE FIRST DIVISION OF THE ST. PAUL AND PACIFIC RAILROAD COMPANY, TO CONSTRUCT A BRANCH LINE FROM SOME POINT IN MEEKER OR WRIGHT COUNTIES, TO THE VILLAGE OF HUTCHINSON, IN McLEOD COUNTY.

*Be enacted by the Legislature of the State of Minnesota :*

SECTION 1. The First Division of the St. Paul & Pacific Railroad Company is hereby authorized to construct a branch line of railroad, extending from some point in Meeker or Wright counties, to the village of Hutchinson, in McLeod county, and the various provisions of the several acts of legislature, relating to the First Division of the St. Paul & Pacific Railway and its branches, are hereby extended to the branch line hereby authorized, so far as the same are applicable. *Provided*, That passengers and freight shall always be carried over the line of railway hereby authorized, at such equitable and reasonable rates, as may from time to time be fixed by law.

SEC. 3. This act shall take effect and be in force from and after its passage.

## CHAPTER CXIX.

AN ACT TO ENFORCE THE PAYMENT OF TAXES, WHICH BECAME DELINQUENT IN CARLTON COUNTY, IN THE YEAR 1875.

PREAMBLE.—*Whereas*, The board of county commissioners of the county of Carlton neglected, in the year 1875, to designate a newspaper in which certain publications should be made as required by an act, entitled, “An act to provide for the assessment and collection of taxes,” approved March 9th, 1874, and the act amendatory thereto, approved March 9th, 1875; and,

WHEREAS, By reason of such neglect the provisions of said act, were not enforced or attempted to be enforced, in said Carlton county, for the collection of the taxes of the year 1874, which became delinquent in the year 1875; therefore,

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. That the auditor of Carlton county shall act and proceed in all respects with regard to the taxes which became delinquent

in said county in 1875, as with the taxes which may become delinquent in 1876, complying in all respects, so far as the same may be applicable, to the provisions of an act, entitled, "An act to provide for the assessment and collection of taxes," approved March 9th, 1874, and the act amendatory thereto, approved March 9th, 1875; and all proceedings for the collection of said taxes which became delinquent in the year 1875, shall be of the same force and validity, as if they had been [done] in the year 1875, the time for such proceeding to collect such delinquent taxes being hereby extended in all respects to the year 1875.

SEC. 2. This act shall be in full force and effect from and after its passage.

#### CHAPTER CXX.

AN ACT TO AUTHORIZE THE AUDITOR OF FARIBAULT COUNTY TO EXTEND CERTAIN TAXES UPON THE BOOKS OF SAID COUNTY.

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. The county auditor of Faribault county is hereby authorized and empowered to extend upon the tax books of said county, and place the same in proper form for collection, the delinquent road tax for the year A. D. 1874, for the town of Winnebago City, in said county.

SEC. 2. This act shall take effect and be in force from and after its passage.

#### CHAPTER CXXI.

AN ACT TO REQUIRE THE COUNTY TREASURER OF STEARNS COUNTY TO PAY CERTAIN MONEYS INTO THE TREASURY OF THE CITY OF SAINT CLOUD.

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. That the county treasurer of the county of Stearns shall hereafter annually pay into the treasury of the city of Saint Cloud, in
