

in said county in 1875, as with the taxes which may become delinquent in 1876, complying in all respects, so far as the same may be applicable, to the provisions of an act, entitled, "An act to provide for the assessment and collection of taxes," approved March 9th, 1874, and the act amendatory thereto, approved March 9th, 1875; and all proceedings for the collection of said taxes which became delinquent in the year 1875, shall be of the same force and validity, as if they had been [done] in the year 1875, the time for such proceeding to collect such delinquent taxes being hereby extended in all respects to the year 1875.

SEC. 2. This act shall be in full force and effect from and after its passage.

CHAPTER CXX.

AN ACT TO AUTHORIZE THE AUDITOR OF FARIBAULT COUNTY
TO EXTEND CERTAIN TAXES UPON THE BOOKS OF SAID COUNTY.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. The county auditor of Faribault county is hereby authorized and empowered to extend upon the tax books of said county, and place the same in proper form for collection, the delinquent road tax for the year A. D. 1874, for the town of Winnebago City, in said county.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER CXXI.

AN ACT TO REQUIRE THE COUNTY TREASURER OF STEARNS COUNTY
TO PAY CERTAIN MONEYS INTO THE TREASURY OF THE
CITY OF SAINT CLOUD.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That the county treasurer of the county of Stearns shall hereafter annually pay into the treasury of the city of Saint Cloud, in

said county, for the use of said city; the whole amount of road and bridge tax levied by the county authorities of said county upon, and collected from the taxable property included within the corporate limits of said city, together with such tax collected during the present year, in the same manner and at the same time that other city taxes are paid over to said city treasury; and the county auditor of said county is hereby authorized to issue the necessary orders therefor.

SEC. 2. All acts and parts of acts inconsistent with this act are hereby repealed.

SEC. 3. This act shall take effect and be in force from and after its passage.

CHAPTER CXXII.

AN ACT TO LEGALIZE AND CONFIRM THE PUBLICATION OF THE DELINQUENT TAX LIST OF HOUSTON COUNTY FOR THE YEAR 1875.

WHEREAS, At the time prescribed by law for the publication of the delinquent tax list of Houston county, for the year A. D. 1875, "The Houston County Journal," a weekly newspaper printed and published in the village of Caledonia, in the aforesaid county, was the only newspaper printed in the said county of Houston, and the said tax list was published in the said "Houston County Journal," in all respects as required by law, although not formally designated by the county commissioners of the aforesaid county, therefore,

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the printing and publication of the delinquent tax list of Houston county for the year of our Lord one thousand eight hundred and seventy-five (1875), in the "Houston County Journal," a weekly newspaper printed and published in the village of Caledonia, in the county of Houston, be and the same is hereby legalized and confirmed, and is hereby declared to be a valid publication, so far as it relates to the printing and publication of the said tax list in the aforesaid "Houston County Journal."

SEC. 2. This act shall take effect from and after its passage.
