CHAPTER CXXXVI.

AN ACT TO NAME A FOUNDLING MAUD C. CAMPBELL, AND TO CONSTITUTE HER THE ADOPTED CHILD AND HEIR AT LAW OF GEORGE C. CAMPBELL AND MELL C. CAMPBELL.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the foundling child now in the care and custody of George C. Campbell and Mell C. Campbell, of Hennepin county, be named Maud C. Campbell and constituted the adopted daughter and heir at law of said George C. and Mell C. Campbell, and entitled to all privileges and rights as if she was the child of said George C. and Mell C. Campbell born in lawful wedlock.

SEC. 2. This act shall take effect and be in force from and after its passage and acceptance (in writing) by said George C. Campbell and Mell C. Campbell duly acknowledged, filed and recorded in the office

of the register of Deeds of Hennepin county.
