SEC. 2. This act shall take effect and be in force from and after its passage; but nothing herein contained shall be construed as interfering with the holding of the term of court on the third (3d) Tuesday in February, one thousand eight hundred and eighty-five (1885), as now provided by law.

CHAPTER 133.

AN ACT TO AMEND THE GENERAL STATUTES OF A. D. ONE THOUSAND EIGHT HUNDRED AND SEVENTY-EIGHT (1878), RELATING TO THE GENERAL TERM OF THE DISTRICT COURT OF POPE COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

Time of holding
general terms
of court.

SECTION 1. The general terms of the district court in and for the county of Pope, in the seventh (7th) judicial district, shall be held on the second (2d) Monday in March and on the third (3d) Monday in October of each year.

Repeal of incon-
sistent acts.

SEC. 2. All acts and parts of acts inconsistent herewith are hereby repealed.

SEC. 3. This act shall take effect and be in force on and after the fourth (4th) day of July, A. D. one thousand eight hundred and eighty-five (1885).

CHAPTER 134.

AN ACT TO AMEND SECTION FIFTY-NINE (59) OF TITLE THREE (3) OF CHAPTER SIXTY-FOUR (64) OF THE GENERAL STATUTES OF A. D. ONE THOUSAND EIGHT HUNDRED AND SEVENTY-EIGHT (1878), RELATING TO THE HOLDING OF THE TERMS OF DISTRICT COURT IN THE FOURTH JUDICIAL DISTRICT.

Be it enacted by the Legislature of the State of Minnesota:

Change of time
holding terms
of court.

SECTION 1. That section fifty-nine (59) of title three (3) of chapter sixty-four (64) of the general statutes of A. D. one

thousand eight hundred and seventy-eight (1878) be amended as follows, to-wit: That all of section fifty-nine (59) after the words "in the county of Wright," in the eighth (8th) line, be stricken out and the following substituted, as follows, to-wit: "On the first (1st) Monday of June and the first (1st) Monday of December."

SEC. 2. This act shall take effect and be in force from and after its passage. When act to take effect.

CHAPTER 135.

AN ACT TO AMEND SECTION FIFTY-SIX (56) OF TITLE THREE (3) OF CHAPTER SIXTY-FOUR (64) OF GENERAL STATUTES OF A. D. ONE THOUSAND EIGHT HUNDRED AND SEVENTY-EIGHT (1878), RELATING TO THE TERMS OF THE DISTRICT COURT OF THE FIRST (1ST) JUDICIAL DISTRICT.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section fifty-six (56) of title three (3) of chapter sixty-four (64) of general statutes of one thousand eight hundred and seventy-eight (1878) be and the same hereby is amended so as to read as follows, to-wit:

Sec. 56. The general terms of the district court of the first (1st) judicial district of this state shall be held at the times following:

In the county of Goodhue, on the second (2d) Tuesday in March and the fourth (4th) Tuesday in October in each year. Time of holding general terms of court.

In the county of Dakota, on the third (3d) Tuesday in January and the third (3d) Tuesday in June in each year.

In the county of Washington, on the fourth (4th) Tuesday in May and the second (2d) Tuesday in November in each year.

In the county of Pine, on the first (1st) Tuesday in October in each year.

In the county of Chisago, on the third (3d) Tuesday in October in each year.

SEC. 2. This act shall take effect and be in force from and after the first (1st) day of July, A. D. one thousand eight hundred and eighty-five (1885). When act to take effect.
