CHAPTER 217.

AN ACT TO AUTHORIZE THE DESTRUCTION OF CERTAIN BONDS HELD BY THE INTERNAL IMPROVEMENT LAND FUND.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. The state treasurer is hereby authorized what bond and directed to destroy the three hundred and twenty-two (322) "Minnesota state railroad adjustment bonds," with attached coupons, that are now held by the internal improvement land fund.

SEC. 2. The governor and the state auditor shall be who to be present when said bonds and coupons are burned up, and shall with the state treasurer certify as to the fact of such destruction on a record which shall contain the number and description of the bonds and coupons so destroyed.

SEC. 3. This act shall take effect and be in force from when act to and after its passage.

CHAPTER 218.

AN ACT TO PROVIDE FOR THE FURNISHING OF THE MIN-NESOTA REPORTS TO CLERKS OF THE DISTRICT COURTS.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. The secretary of state is hereby authorized to furnish to the several clerks of the district courts, and judges of the municipal courts, one copy each of Minnesota tributed. supreme court reports, such reports to remain the property of the state in the custody of said clerks during their respective terms of office, and then to be delivered by them to their successors in office.

SEC. 2. It shall be the duty of each of said clerks to In whose cuskeep the said reports in the court rooms during sessions of court, and at other times they shall be kept in the office of the clerk of the district court, for the use of the county and town officers and other citizens of the state. clerks shall not permit any of said reports to be taken out of their offices except during sessions of the district court in their respective counties, at which times said clerks shall keep the reports in the court rooms, and shall not permit them to be taken therefrom.

SEC. 3. For the purpose of carrying out the provisions of this act, and for any other purpose already provided for by law, the secretary of state is hereby authorized to purchase the requisite number of volumes of said reports at a price not to exceed two-thirds $(\hat{\pi})$ of the present market price of said volumes, payable one-third $(\frac{1}{2})$ of the amount during the year one thousand eight hundred and eightyfive (1885), one-third $(\frac{1}{2})$ during the year one thousand eight hundred and eighty-six (1886), and the balance during the year following. The volumes so purchased to be in every respect equal to the copies heretofore furnished the state as provided by law.

SEC. 4. The sum of three thousand (3,000) dollars, or so much thereof as may be necessary to pay one-third $(\frac{1}{2})$ of the amount of the whole purchase, is hereby appropriated for the year one thousand eight hundred and eighty-five (1885), out of any moneys in the treasury not otherwise appropriated, and a like amount for each of the years one thousand eight hundred and eighty-six (1886) and one thousand eight hundred and eighty-seven (1887), is also hereby appropriated out of any moneys in the treasury not otherwise appropriated, to pay the balance of the amount of said purchase.

SEC. 5. This act shall take effect and be in force from and after its passage.
