SEC. 5. All bills or accounts against the said state institutions (except the historical society) shall be made out and receipted in duplicate, and on forwarding the pay rolls and expense lists for each month, the said accounting officers shall also forward one (1) set of such bills and vouchers for the preceding month, and shall be compared by the state auditor with the proper pay rolls and lists, and filed in his office and preserved for public inspection.

## CHAPTER 295.

AN ACT TO APPROPRIATE MONEY FOR HOSPITALS FOR INSANE ACCOUNT AND FOR THE PURPOSES THEREIN NAMED.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. That the following sums of money, or so much thereof as may be necessary, be and the same is hereby appropriated out of any money in the state treasury not otherwise appropriated for the following purposes:

For the hospital for insane at St. Peter, to be drawn from the revenue fund.

*First*—For building and furnishing detached wards in one thousand eight hundred and eighty-five (1885), fifty thousand (50,000) dollars.

*Second*—For building and furnishing detached ward in one thousand eight hundred and eighty-six (1886), twenty-five thousand (25,000) dollars.

*Third*—For improving centre building and making basement of same fireproof, three thousand (3,000) dollars.

*Fourth*—For barn and root cellar, three thousand five hundred (3,500) dollars.

*Fifth*—For repairing, annually, three thousand (3,000) dollars.

For second hospital for insane at Rochester:

*Seventh*—For stock barn on east farm, twenty-five hundred (2500) dollars.

*Eighth*—For purchase of pasture land, twelve hundred (1200) dollars.

*Ninth*—For duplex pump and centrifugal wringer, one thousand (1,000) dollars.

*Tenth*—For additional boiler, one thousand (1,000) dollars.

*Eleventh*—For hose and hose reels, one thousand (1,000) dollars.

*Twelfth*—For repairs, annually, two thousand (2,000) dollars.

*Thirteenth*—For building and furnishing detached wards in one thousand eight hundred and eighty-six (1886), fifty thousand (50,000) dollars; *Provided*, That items one (1), three (3), seven (7), eight (8), nine (9), ten (10) and eleven (11) be payable during the fiscal year ending July thirty-first (31st), one thousand eight hundred and eighty-six (1886), and items two (2), four (4) and thirteen (13) be payable during the fiscal year ending July thirty-first (31st), one thousand eight hundred and eighty-seven (1887), and that items five (5) and twelve (12) be payable for two (2) years only, ending July thirty-first (31st), one thousand eight hundred and eighty-six (1886), and July thirty-first (31st), one thousand eight hundred and eighty-seven (1887).
