

CHAPTER 296.

AN ACT TO APPROPRIATE MONEY FOR BUILDING AN ADDITION TO THE STATE NORMAL SCHOOL BUILDING AT MANKATO, AND A NORMAL HOUSE FOR THE USE OF THE NORMAL SCHOOL AT WINONA, AND FOR COMPLETING THE NORMAL HOUSE OF THE STATE NORMAL SCHOOL AT SAINT CLOUD, AND FOR THE PAYMENT OF DIFFERENCES OF THE STATE NORMAL SCHOOL AT MANKATO FOR THE YEAR A. D. ONE THOUSAND EIGHT HUNDRED AND EIGHTY-FOUR (1884), AND FOR THE PURCHASE OF FURNITURE AND APPARATUS FOR THE STATE NORMAL SCHOOL AT SAINT CLOUD, AND FOR REPAIRING THE BUILDINGS OF THE [STATE] NORMAL SCHOOL AT WINONA AND TO INCREASE THE STANDING APPROPRIATION FOR EACH OF THE SAID NORMAL SCHOOLS.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That there is hereby appropriated out of any money in the state treasury, or which shall come into the state treasury, not otherwise appropriated, the following sums, viz: For completing the normal home of the state normal school at Saint Cloud, the sum of sixteen thousand dollars (\$16,000), and for furnishing the said normal home the sum of three thousand five hundred dollars (\$3,500), and for furniture for class rooms in state normal school at Saint Cloud, two hundred and fifty dollars (\$250). Said sums to be payable during the fiscal year ending July thirty-first (31st) A. D. one thousand eight hundred and eighty-six (1886), and for apparatus for same school, two hundred and fifty dollars (\$250). Said sum to be payable during the year ending July thirty-first (31st), A. D. one thousand eight hundred and eighty-seven (1887), and one thousand five hundred dollars (\$1,500) for painting and kalsomining and reflooring the rooms of the buildings of the state normal school at Winona. Said sums to be payable during the fiscal year ending July thirty-first (31st) one thousand eight hundred and eighty-six (1886). For deficiency and to pay unpaid accounts and expenses of the state normal school at Mankato for the year A. D. one thousand eight hundred and eighty-four (1884), two thousand dollars (\$2,000).

Appropriations for completing and repairing normal school buildings.

SEC. 2. The several sums aforesaid shall be expended under the direction of the state normal board.

How expended.

SEC. 3. This act shall take effect and be in force from and after its passage.

When act to take effect.
