

CHAPTER 76.

AN ACT TO AMEND SECTION SIXTEEN (16) OF CHAPTER THIRTY-NINE (39) OF THE GENERAL STATUTES OF ONE THOUSAND EIGHT HUNDRED AND SEVENTY-EIGHT (1878), AS AMENDED BY SECTION TWO (2) OF CHAPTER THIRTY-EIGHT (38) OF THE GENERAL LAWS OF ONE THOUSAND EIGHT HUNDRED AND EIGHTY-THREE (1883), RELATING TO CHATTEL MORTGAGES.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section sixteen (16) of chapter thirty-nine (39) of the general statutes of one thousand eight hundred and seventy-eight (1878), as amended by section two (2) of chapter thirty-eight (38) of the general laws of one thousand eight hundred and eighty-three (1883), be and the same hereby is amended by inserting the word "vendee" in the place of the word "vendor," first occurring in said section sixteen (16) as amended.

Strike out and insert.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 77.

AN ACT ENTITLED AN ACT TO AMEND SECTION SIX (6) OF CHAPTER ONE HUNDRED AND FORTY-TWO (142) OF THE GENERAL STATUTES OF ONE THOUSAND EIGHT HUNDRED AND EIGHTY-THREE (1883), RELATING TO THE STATE AGRICULTURAL SOCIETY AND OTHER AGRICULTURAL SOCIETIES.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section six (6) of chapter one hundred and forty-two (142) of the general statutes of one thousand eight hundred and eighty-three (1883) be and the same is hereby amended by striking therefrom the words and figures, "six thousand dollars (\$6,000)," appearing in the first (1st) line of said section six (6), and inserting in lieu thereof the words and figures, "twelve thousand dollars (\$12,000)," and adding after the word "sureties," in the

sixth (6th) line of said section six (6), "and the further sum of two thousand dollars (\$2,000) be annually appropriated to the Southern Minnesota fair association, to be paid by the state treasurer on the order of the president and secretary of the Southern Minnesota fair association."

CHAPTER 78.

AN ACT TO AMEND SECTION TWENTY-TWO (22), CHAPTER ELEVEN (11) OF THE GENERAL STATUTES OF THE STATE OF MINNESOTA OF A. D. ONE THOUSAND EIGHT HUNDRED AND SEVENTY-EIGHT (1878), RELATING TO TAXATION.

Be it enacted by the Legislature of the State of Minnesota:

When mort-
gages exempt
from taxation.

SECTION 1. That section twenty-two (22), chapter eleven (11), is hereby amended by adding thereto the following, viz.: The monthly installments deposited in building associations and subject to withdrawal on demand, or on thirty (30) or sixty (60) days' notice, as provided in the by-laws of such associations, are an indebtedness which may be deducted from the value of their stock as provided in this section. Mortgages of said associations, which are represented in their stock and assessed as stock, shall not be assessed as mortgages. They shall list their real estate and all personal property as provided in this section.
