# CHAPTER 224.

AN ACT TO LEGALIZE THE LEVY OF TAXES THAT HAVE BEEN LEVIED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF ST. VINCENT, KITTSON COUNTY, FOR THE PURPOSE OF PAYING THE INTEREST ON CERTAIN BONDS.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the levy of all taxes that have heretofore been levied by the board of trustees of the village of St. Vincent, Kittson county, this state, for the purpose of providing for the payment of the interest of eight thousand (8,000) dollars, bonds of the said village, be and the same is hereby legalized and made valid.

SEC. 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 225.

### AN ACT TO LEGALIZE THE ISSUE OF BONDS VOTED BY THE INDE-PENDENT SCHOOL DISTRICT OF THE CITY OF FERGUS FALLS.

#### Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the action of the board of education of the city of Fergus Falls, held on the ninteenth (19th) day of August, A. D. one thousand eight hundred and eighty-four (1884), calling for a meeting of the legal voters of said district on September sixth (6th), A. D. one thousand eight hundred and eighty-four (1884), for the purpose of voting upon the issue of bonds to purchase a site and build a school house in the second (2d) ward in said city, and the action of the legal voters assembled on said sixth (6th) day of September, A. D. one thousand eight hundred and eighty-four (1884), in voting to issue filteen thousand (15,000) dollars in bonds, to purchase a site and build a school house in the second (2d) ward in said city; and any and all action taken by said board of education in the purchase of a site and materials, and towards the construction of said building; and any and all action in the issue of said bonds in pursuance of said meetings, are hereby validated and legalized, and the said bonds now issued or to be issued under said proceedings are hereby declared to be legal and valid.

SEC. 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 226.

### AN ACT LEGALIZING THE VOTE OF THE VOTERS OF THE TOWN OF WAKEFIELD, IN STEARNS COUNTY, IN REGARD TO THE ISSUANCE OF CERTAIN BRIDGE BONDS AND THE ISSUES MADE THEREUNDER AND AUTHORIZING THE ISSUANCE OF NEW BONDS UNDER CERTAIN CIR-CUMSTANCES.

THAT WHEREAS, At a special town meeting held at the City Hotel in Cold Springs city in the town of Wakefield, county of Stearns, and state of Minnesota, on the fifth (5th) day of April A. D. one thousand eight hundred and eighty-four (1884), the question of the issuance of the bonds of said town in the sum of three thousand five hundred (3,500) dollars, to aid in the construction of a bridge across Sauk river in said town below the mill dam, was submitted to the legal voters thereof, and the vote was taken, properly canvassed and was declared to be carried in favor of the issuance of said bonds; AND WHEREAS, The bonds of said town have been issued in pursuance to the will of the people, as expressed in said vote; now therefore,

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That all and singular the acts and proceedings of said town and the officers thereof, in submitting to the legal voters thereof the proposition in regard to the issuance of bonds to pay for building or to aid in the construction of a bridge across the Sauk river, just below the present mill dam in said town; as well as the canvass of the vote and the making declaration thereof and the issuance of bonds in pursuance of said vote in the sum of thirty-five hundred (3,500) dollars, together with the manner, form and order of issuing the same,
