his labor, what his services are reasonably worth, and also the actual amount of his traveling and other expenses necessarily incurred in the performance of the duties of his office. And the county commissioners of said county shall provide and furnish a suitable office for said county surveyor.

Sec. 2. All acts or parts of acts inconsistent with this act, in so far

as Washington county is concerned, are hereby repealed.

SEC. 3. This act shall take effect and be in force from and after the date of its passage.

CHAPTER 244.

AN ACT TO FIX THE COMPENSATION TO BE PAID BY THE COUNTY OF RAMSEY TO THE SHERIFF THEREOF FOR HIS SERVICES TO SAID COUNTY AND THE STATE.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. The sheriff of Ramsey county shall not be entitled to any fees or compensation from said county for any services mentioned in section four (4) of chapter two hundred and eighty-six (286) of the special laws of one thousand eight hundred and eighty-three (1883), entitled "An act to regulate the salary and fees of certain officers in Ramsey county, and prescribing their duties," nor for any services which he may perform for said county or state, except as herein provided.

SEC. 2. The said sheriff shall render and perform for said county and state the services mentioned in said section four (4) of said chapter two hundred and eighty-six (286) of the special laws of one thousand eight hundred and eighty-three (1883), and all other public duties and services which may devolve upon him by law or order of court, and as full compensation therefor shall be paid by said county two hundred (200) dollars per month, and no more, except as herein further provided. If, in the discharge of any of his duties, said sheriff shall be required to travel outside the limits of said county, he shall be entitled to the further compensation of ten (10) cents per mile travel outside of said county, going and returning.

Sec. 3. The said sheriff shall also appoint two watchmen, one turnkey, and one janitor or fireman, in connection with the jail building, and two janitors for court house and county offices, each at a salary of not exceeding sixty (60) dollars per month, to be also paid by the county. He shall also appoint the following bailiffs, viz.: Three for the grand jury during their sittings; two for the court while engaged in the trial of jury cases; and one for each judge when engaged in the hearing of court cases and motions, each at a compensation of two dollars and fifty cents (\$2.50) per day, to be also paid by the county. Said bailiffs shall have power to summons jurors, serve subpenas, and shall perform such other duties as the court may order or direct, but shall receive no extra compensation therefor. The said sheriff shall also be entitled from said county to two (2) dollars per week for the time he boards and has charge of each prisoner. For any services performed by said sheriff where the compensation therefor does not come from or through the county treasurer, his fees for such services shall remain as now provided by law.

SEC. 4. This act shall take effect and be in force from and after

its passage.

CHAPTER 245.

AN ACT RELATING TO THE DUTIES AND COMPENSATION OF THE COUNTY SURVEYOR OF HENNEPIN COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. The county surveyor of the county of Hennepin shall be entitled to receive five (5) dollars per day as compensation for his services for each day employed in the discharge of his duties as such surveyor, including the time necessarily spent in traveling to and from the field of his labor, and also the actual amount of his traveling expenses incurred while engaged upon the work; and said county surveyor shall also be entitled to receive the sum of two and a quarter (2½) dollars per day for each and every assistant necessarily employed on said field of labor, together with the actual necessary expenses of said assistant, incurred while engaged upon the work; and the sum of four (4) dollars per day for each and every assistant while employed as draftsman in preparing plats of said survey, or any plats ordered or directed by any of the officers, boards or persons hereinafter specified.

SEC. 2. The said surveyor may appoint such number of deputies as he thinks proper, who shall severally take an oath, and for the faithful performance of whose duties he shall be responsible; and by himself, or by one of said deputies, shall execute any and all surveys which may be required or ordered by any court having jurisdiction
