SEC. 4. Nothing contained in this act shall permit any city operating or extending an electric light plant in accordance with the foregoing provisions to increase its bonded indebtedness.

SEC. 5. This act shall take effect and be in force from and after its passage.

## CHAPTER 67.

An act to amend Section 1, of Chapter 134, of the Salaries General Laws of the year 1899, relating to salaries of judges, district judges.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That Section 1, of Chapter 134, of the General Laws of the year 1899, be and hereby is amended so as to read as follows:

Section 1. The judges of the district court shall each receive a salary of three thousand five hundred (3,500) dollars per annum, provided, that when any county shall have a population of one hundred thousand (100,000) or more there shall be paid annually by each said county out of the county funds, to each of the said judges of the district court of such county, the sum of fifteen hundred (1,500) dollars, in addition to said sum of three thousand five hundred (3.500) dollars, and all salaries and compensation of the judges of the district court of this state shall be payable monthly, subject however, to the provisions of Chapter 47 of the General Laws of this state for the year 1901.

SEC. 2. This act shall take effect and be in force from and after its passage.

An act to amend section forty-nine hundred twelve (4912) of the statutes of eighteen hundred ninety-four (1894), relating to terms of district court in the First Judicial District.

Be it enacted by the Legislature of the State of Minnesota:

"Section 4912. In First District---

"The general terms of the district court of the First Judicial district of this state shall be held at the times following:

"In the County of Goodhue, on the second Wednesday in March and the third Tuesday in October, in each year.

"In the County of Dakota, on the first Tuesday in June and the second Tuesday in December, in each year.

"In the County of Washington, on the first Tuesday in May and the third Tuesday in November, in each year.

"In the County of Pine, on the second Tuesday in April and the third Tuesday in September, in each year.

"In the County of Chisago, on the first Wednesday in October, in each year.

"In the County of Kanabec, on the third Tuesday in August, in each year."

SEC. 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 69.

An act prescribing the times for holding general terms of the district court in the County of Jackson, in the Seventeenth Judicial district.

Be it enacted by the Legislature of the State of Minnesota:

SECTION I. The general terms of the district court in the County of Jackson, in the Seventeenth Judicial district, shall be held on the third Tuesday in May and the third Tuesday in November of each year.

SEC. 2. All writs, recognizances, bonds, continuances and proceedings issued made or returnable to the district court of said county, as fixed by law prior to the passage of this act, shall be and the same hereby are made returnable to the terms of said court as the same are prescribed by the provisions of section one (1) of this act.
