Sec. 11. District and municipal judges given the right to sentence to correction farm.—The judges of all district and municipal courts and justices of the peace in any such county, shall have the same power to sentence any person to confinement at hard labor on said work or correction farm, as said judges and justices of the peace now have to sentence any person convicted of crime, to a county jail, workhouse or lockup in such county.

CHAPTER 189-S. F. No. 373.

An Act to amend Section 3587 of the Revised Laws of Minnesota for 1905, relating to proceedings in divorce.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Wife may secure only one-half of property to which she procured title through husband, when husband obtains divorce.—That Section 3587, Revised Laws of Minnesota for 1905, be and the same is hereby amended so as to read as follows:

"Sec. 3587. Whenever a divorce is granted from the bonds of matrimony for any cause, except adultery committed by the wife, or from bed and board, or the husband is sentenced to imprisonment for life, or the marriage is adjudged null, the wife shall be entitled to the immediate possession of all her Real Estate. But in case of a divorce obtained by a husband any real or personal property to which she procures title through her husband, not exceeding one-half thereof, may be decreed to be and belong to the husband; the Court having regard to the ability, character and situation of the parties, and other circumstances of the case."

Sec. 2. The provisions of this act shall apply to all proceedings that are now pending as well as those hereafter com-

menced.

Sec. 3. All acts and parts of acts inconsistent herewith are hereby repealed.

CHAPTER 190-S. F. No. 69.

An Act to amend Section 1, Chapter 80 of the General Laws 1911, Entitled, "An Act fixing the salary and compensation of Clerks of the District Court, the appointment of deputy clerks, their compensation and dutics, in counties having, or which may hereafter have, a population of not less than 200,000 and less than 275,000 inhábitants."

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Seven deputy clerks in certain counties for clerk of court.—That Section 1 of Chapter 80, of the General Laws of 1911 be amended so as to read as follows:

"Section 1. In all counties of this state that now have or may hereafter have a population of not less than two hundred thousand and less than two hundred and seventy-five thousand inhabitants, the salary of the clerk of the District Court shall be forty-five hundred dollars per annum. In all such counties said clerk shall appoint and employ eleven deputy clerks of said District Court, whose duties shall be designated by said clerk and who shall be paid the following salaries: one deputy clerk who shall be paid twenty-five hundred dollars per annum, one deputy clerk who shall be paid fifteen hundred dollars per annum, one deputy clerk who shall be paid fourteen hundred dollars per annum, one deputy clerk who shall be paid fourteen hundred dollars per annum and seven deputy clerks who shall each be paid twelve hundred dollars per annum."

Sec. 2. All acts and parts of acts inconsistent herewith are

hereby repealed.

Sec. 3. This act shall take effect and be in force from and after its passage.

CHAPTER 191—S. F. No. 271.

An Act to amend Chapter 122, General Laws 1911, relating to the salary and duties of the clerk of the juvenile division of the district court, in counties having not less than two hundred thousand nor more than two hundred and seventy-five thousand inhabitants.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Salary of clerk of juvenile court fixed at \$1,800 per annum.—That Chapter 122, General Laws of the State of Minnesota, be amended to read as follows:

"Section 1. That in counties having not less than two hundred thousand nor more than two hundred seventy five thousand inhabitants, the judge assigned to hear and try cases under the juvenile court act, shall designate a duly appointed deputy clerk of the district court to act as clerk of the juvenile division of the district court, which deputy () shall be in addition to the deputy clerks now provided by law."

Sec. 2. Said clerk of the juvenile division of the district court shall keep all books and records thereof, issue summons
