CHAPTER 27-S. F. No. 27.

An act authorizing the county board of any county of this state now or hereafter having taxable property of not less than \$300,000,000, to appropriate and expend not more than \$20,000 from the general revenue fund to defray part of the cost of furnishing and crecting a public monument in such county, in memory of the soldiers and sailors of the nation.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. County board of St. Louis county permitted to appropriate \$20,000 as part cost for monument in memory of soldiers and sailors.—That the county board in any county of this state now or hereafter having taxable property of an assessed valuation of not less than \$300,000,000, and having therein a city of the first class, may at any time after the taking effect of this act, appropriate and expend from the general revenue fund of said county, a sum not exceeding \$20,000 to defray part of the cost of providing and erecting a suitable public monument in memory of the soldiers and sailors of the nation, upon a location in said county within four hundred feet of the county court house in said county, provided a sum equal to that appropriated and expended by such county shall also be contributed to the cost of furnishing and erecting such monument, by any such city of the first class in said county and by private donations, or by either of the same, to defray the remainder of the cost of furnishing and erecting such monument.

Sec. 2. This act shall take effect from and after its passage.

CHAPTER 28—S. F. No. 150.

An act to revive, renew and extend certain expired logging vermits.

Whereas on account of the heavy-snow and storms of the winter of 1915-1916 many holders of logging permits could not cut and remove the timber from the lands mentioned in such permits before the expiration of the same; Therefore

Bt it enacted by the Legislature of the State of Minnesota:

Section 1. Logging permits extended to June 1, 1917, under certain conditions.—All logging permits, the holders of which could not cut and remove the timber described in them before their expiration, whether said expiration was at the time of the original expiration or after one or more extensions thereof, are hereby extended for another logging season ending June 1, 1917,

provided, that the facts relative to the failure to cut and remove timber under said permits be presented to the board of timber commissioners within thirty (30) days from the passage of this act and be found by said board sufficient justification for the failure of said logging permit holders to conform to the terms of said permits prior to June 1, 1916.

Sec. 2. This act shall take effect and be in force from and

aftér its passage.

CHAPTER 29-H. F. No. 173.

An act to amend Section 1, Chapter 138, General Laws 1915, relating to insurance corporations, the kinds of business such corporations may transact and authorizing amendments to the charters of such corporations to permit the doing of such business.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Procedure for amendment to charter or certificate of insurance companies.—That Section 1, Chapter 138-of the General Laws, 1915, be and the same is hereby amended by adding thereto the following subdivision:

- 16. The charter or certificate of incorporation of any insurance corporation organized under any general or special law may be amended in respect to any matter which an original certificate of a corporation of the same kind may lawfully have contained by the adoption of a resolution specifying the proposed amendment and by the approval, filing, recording and publication of the same in the manner prescribed by the general laws of this state relating to amendments to certificates of incorporation.
- Sec. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 30-S. F. No. 77.

An act authorizing the renewal of the period of corporate existence of certain corporations whose period of duration has expired without renewal thereof.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Extension of period of existence of certain corporations authorized.—Any corporation heretofore organized, for pecuniary profit, under the laws of this state, whose period of duration has expired less than four years prior to the passage of this act, and, through inadvertance or otherwise, the same has not been renewed, and such corporation has continued to
