CHAPTER 151—S. F. No. 254

An act to amend General Statutes 1923, Section 2844, relating to the compensation of certain School Officers.

Be it enacted by the Legislature of the State of Minnesota :

Section 1. Compensation of officers of independent districts.—That General Statutes 1923, Section 2844, be amended to read as follows :

"2844. The clerk, *or secretary*, treasurer and superintendent of independent *and special* districts shall receive such compensation as may be fixed by the board. No officer or member of any school board shall receive pay as such, except as provided in this chapter."

CHAPTER 152—S. F. No. 357

An act to amend Section 6, of Chapter 419, General Laws 1923, as amended by Section 1, of Chapter 125, Laws 1927, relating to the Salaries, Compensations, Duties, and Help of certain county officials in counties having, or which may hereafter have, a population of 380,000 inhabitants or over.

Be it enacted by the Legislature of the State of Minnesota :

Section 1. Deputies and assistants.—That Section 6, of Chapter 419, General Laws 1923, as amended by Section 1, Chapter 125, Laws 1927, be and the same is hereby amended so as to read as follows :

"Sec. 6. The Sheriff shall appoint and employ one chief deputy who shall be paid the sum of twenty-nine hundred forty (\$2,940.00)

dollars per annum; one assistant chief deputy and Auditor who shall be paid the sum of twenty-two hundred (\$2,200.00) dollars per annum; one assistant bookkeeper who shall be paid the sum of sixteen hundred fifty (\$1,650.00) dollars per annum; one special deputy who shall be paid the sum of sixteen hundred fifty (\$1,650.00) dollars per annum; one deputy for tax collections, who shall be paid the sum of sixteen hundred fifty (\$1,650.00) dollars per annum; four outside deputies who shall each be paid the sum of two thousand two hundred (\$2,200.00) dollars per annum; one deputy for the care of the insane, who shall be paid the sum of seventeen hundred sixty (\$1,760.00) dollars per annum; three outside deputies to attend to the service of criminal and other processes, who shall each be paid the sum of seventeen hundred and sixty (\$1,760.00) dollars per annum; one jailer who shall be paid the sum of seventeen hundred and five (\$1,705.00) dollars per annum; four outside criminal deputies who shall each be paid the sum of twenty-four hundred (\$2,400.00) dollars per annum; twelve uniformed motorcycle deputies, each deputy to furnish his own motorcycle, maintenance thereof, and uniform, who shall each be paid the sum of two thousand four hundred (\$2,400.00) dollars per annum; one assistant jailer who shall be paid the sum of sixteen hundred and fifty (\$1,650.00) dollars per annum; one matron who shall be paid the sum of nine hundred ninety (\$990.00) dollars per annum; four night watchmen who shall each be paid the sum of fourteen hundred and fifty (\$1,450.00) dollars per annum; one cook who shall be paid the sum of thirteen hundred and twenty (\$1,320.00) dollars per annum; two deputies in charge of juries who shall each be paid the sum of seventeen hundred and sixty (\$1,760.00) dollars per annum; eight general deputies who shall each be paid the sum of sixteen hundred and fifty (\$1,650.00) dollars per annum; two outside patrol deputies who shall each be paid the sum of sixteen hundred and fifty (\$1,650.00) dollars per annum; three general deputies who shall each be paid the sum of nineteen hundred and eighty (\$1,980.00) dollars per annum; one stenographer who shall be paid the sum of thirteen hundred and twenty (\$1,320.00) dollars per annum. The Sheriff shall also appoint and employ as many court room deputies as there are district court judges in and for said county. Said deputies shall attend the court of said judges and perform such duties pertaining to the sheriff's office as the sheriff may require; the compensation of each of said deputies shall be sixteen hundred and fifty (\$1,650.00) dollars per annum.

Six General Deputies for night duty who shall each be paid the sum of sixteen hundred fifty (\$1,650.00) dollars per annum; one female deputy or bailiff to attend on mixed juries, who shall be paid the sum of thirteen hundred twenty (\$1,320.00) dollars per annum.

An expense fund of two thousand (\$2,000.00) dollars shall be set aside out of the first moneys received as fees from and after the passage of this act to be used by the sheriff to meet the current monthly expenses of the office, the money so used to be replaced in said fund at the end of each month when such expense is allowed by the County Board.

Any additional salaries provided for in this act, unless otherwise provided for, shall be paid out of any money in the county treasury not otherwise appropriated."

CHAPTER 153—S. F. No. 358

An act to enable each city of the first class of this State now or hereafter having a population of 50,000 inhabitants or more, and the Board of Park Commissioners thereof, including each such city now or hereafter operating under a home rule charter adopted under and pursuant to Section 36, Article 4, of the State Constitution, and having a Board of Park Commissioners to accept the resignation of the members of said board.

Be it enacted by the Legislature of the State of Minnesota :

Section 1. **Members of park board may resign.**—In each city of the first class of this state now or hereafter having a population of 50,000 inhabitants or more including each such city now or hereafter operating under a home rule charter adopted under and pursuant to Section 36, Article 4, of the State Constitution, the Board of Park Commissioners of said city, if any such there be, shall have full power and authority to accept the resignation of any member of said Board, anything in the charter of said city to the contrary notwithstanding.

Sec. 2. This act shall take effect and be in force from and after its passage.
