

(4) *Fifteen miles an hour in going around curves or along a grade upon highway when the driver's view is obstructed within a distance of one hundred feet along such highway in the direction in which he is proceeding;*

(5) *Twenty miles an hour on any highway where the same passes through closely built-up portions of any municipality or where the traffic is congested, when traffic on such highways is controlled at intersections by traffic officers or traffic control devices;*

(6) *Fifteen miles an hour on all other highways where the same pass through the closely built-up portion of any municipality or where the traffic is congested;*

(7) *Twenty miles an hour on any highway where the same passes through the residence portion of any municipality;*

(8) *Forty-five miles an hour under all other conditions."*

CHAPTER 159—S. F. No. 787

An act authorizing the Board of Control to sell and convey to the Church of St. Michael of Stillwater, Minnesota, a corporation, certain lands in the south half of the southwest quarter of Section 3, Township 29 North, Range 20 West, Washington County.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Board of Control may dispose of property in certain cases.**—The Board of Control is hereby authorized to sell on such terms as it deems proper to the Church of St. Michael of Stillwater, Minnesota, a corporation, the following described land owned by the State in Washington County, to-wit: All that part of the south half of the southwest quarter ($S\frac{1}{2}$ of $SW\frac{1}{4}$) of Section 3, Township 29, Range 20 west, described as follows: Beginning at a point 30 feet west of the southwest corner of Block No. 4 of Secrest & Perra's addition to Baytown, at the southwest corner of what is known as St. Michael's Cemetery; thence westerly 300 feet upon the prolongation of the southerly boundary line of said St. Michael's Cemetery; thence north at right angles 600 feet to a point; thence east at right angles 300 feet more or less to the westerly line of said St. Michael's Cemetery; thence south along said westerly line of St. Michael's Cemetery to the place of beginning, all

lying and being in the county of Washington and State of Minnesota.

Sec. 2. State to execute deed.—Upon the terms of such sale being agreed upon between the Board of Control and said corporation and upon the agreed purchase price being paid to the State Treasurer the said land shall be conveyed to said corporation by deed executed under the seal of the State by the Governor and attested by the State Auditor.

CHAPTER 160—S. F. No. 833

An act to amend Section 707, General Statutes 1923, relating to the Establishment and Maintenance of County Tuberculosis Sanatoria.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Membership of commission for sanatorium controlled by two or more counties.—That Section 707, General Statutes of Minnesota for the year 1923, be and the same is hereby amended to read as follows:

“707. Two or more counties may unite in acquiring, establishing, equipping or maintaining such sanatorium and in such case said commission shall be composed in the first instance of two members chosen from each county in such group of the county commissioners of each such county, and after the site for the sanatorium has been selected and has received the approval of the advisory commission of the Minnesota Sanatorium for Consumptives such commission shall be increased by the addition of a third member chosen from the county in which said sanatorium is to be located, by the county commissioners thereof;”

Such site may include lands upon which there are already erected a building or buildings, if the same are suitable and can be utilized in whole or in part for sanatorium purposes.

“Under the first appointment one member from each county shall be chosen to hold office for two years and one for three years from the first Monday of the next July following such appointment, and the additional member thereafter chosen from the county in which said sanatorium is to be located shall be chosen to hold office
