CHAPTER 81-S. F. No. 668

An act to amend Chapter 323, Session Laws of Minnesota for 1931, being an act relating to wild animals, amending Mason's Minnesota Statutes of 1927, Section 5568, as amended, and Section 5574, with respect to the spearing of fish.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Pike and Pickerel open season.—Mason's Minnesota Statutes of 1927, Section 5568, as amended by Laws 1929, Chapter 323, is hereby amended to read as follows:

"5568. Wall-eyed pike (except sand pike), Great Northern pike or pickerel, and yellow perch, may be taken by angling and thereafter possessed, between May 15th and February 1st following, both inclusive.

Providing however, that in St. Louis, Lake and Cook Counties, Great Northern pike or pickerel may be taken by angling and thereafter possessed between May 15th and March 15th following, both inclusive.

A person may take not to exceed eight (8) such pike, Great Northern Pike or Pickerel, in a day, and may have not to exceed sixteen (16) such pike, Great Northern Pike or Pickerel in his possession at one time. Yellow Perch may be taken and possessed without limit as to number; provided, that the commissioner may, whenever he deems it necessary to prevent the undue depletion of perch in any waters, fix by regulation a limit of twenty-five (25) perch per day therein. All such fish taken, regardless of size, may be retained in possession and counted.

Wall-eyed Pike, Great Northern pike or pickerel, and perch, except those taken from waters which may be open for the sale thereof by the commissioner, may not be bought or sold at any time. Great Northern pike or pickerel may be taken by spearing except during the closed season therefor."

CHAPTER 82-S. F. No. 681

An act to repeal Chapter 278, General Laws of Minnesota for the year 1931, entitled "An Act requiring banks and certain corporations to report to the Minnesota Tax Commission information as to their net income, net profits and taxes paid, and providing penalty for failure so to do."

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Law repealed.—Chapter 278, General Laws of Minnesota for the year 1931, is hereby repealed.

Sec. 2. This Act shall take effect and be in force from and after its passage.

CHAPTER 83-H. F. No. 681

An act authorizing the Department of Rural Credit to assign mortgages held by it in certain cases:

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Department of Rural Credit may assign mortgages in certain cases.—In the event of the death of a mortgagor to whom a loan has been granted by the Department of Rural Credit and whose surviving spouse and/or children desire to continue the ownership and in the possession of the premises pledged as security for such loan, the Department of Rural Credit may, in its discretion, upon payment in full of any such loan and the accrued interest thereon, assign and transfer the mortgage given to secure such loan, to the surviving spouse and/or children of such decedent mortgagor.

Sec. 2. This Act shall take effect from and after its passage. Approved March 16, 1933.

CHAPTER 84—S. F. No. 839

An act relating to the time of holding annual meetings in certain school districts.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Annual school meetings.—In any school district in this state whether organized under a general or a special law, where the annual meeting is required by law to be held on the first Monday of September in each year, the time of such annual meeting is hereby changed to the third Tuesday of July in each year, commencing with the third Tuesday of July, 1933.
