CHAPTER 190—S. F. No. 728

*An act to amend Mason's Minnesota Statutes, 1927, Section 9540, relating to the sale of real property under an action for partition.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Sale of real property under action for partition.**—That Mason's Minnesota Statutes, 1927, Section 9540, be and the same is hereby amended so as to read as follows:

"The sale may be by public auction to the highest bidder for cash, upon published notice in the manner required for the sale of real property on execution. The notice shall state the terms of the sale; and if the property, or any part of it, is to be sold subject to a prior estate, charge, or specific lien, the notice shall so state. The terms of sale shall be made known at the time thereof, and, if the premises consist of distinct farms or lots, they shall be sold separately. The court may, if it be for the best interests of the owners of said property, order such property sold by private sale. If a private sale be ordered the real estate shall be appraised by two or more disinterested persons under order of the court, which appraisal shall be filed before the confirmation of the sale by the court. No real estate shall be sold at private sale for less than its value as fixed by such appraisal. The court may order sale of real estate for cash, part cash and a purchase money mortgage of not more than fifty per cent of the purchase price, or on contract for deed."

CHAPTER 191—S. F. No. 834

*An act exempting the net amount payable under policies of accident and disability insurance from the claims of creditors.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Exemption of insurance policies.**—The net amount payable to any insured or to any beneficiary under any policy of accident or disability insurance, or under accident or disability clauses attached to any policy of life insurance, shall be exempt and free and clear from the claims of all creditors of such insured or such beneficiary, and from all legal and judicial processes of execution, attachment, garnishment, or otherwise whatsoever.

CHAPTER 192—S. F. No. 896

*An act relating to the compensation of jurors in counties now or hereafter having a population of more than 200,000 residents and an area of more than 5,000 square miles.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Compensation of jurors in certain counties.**—That hereafter each grand and petit juror serving in counties now or hereafter having a population of more than 200,000 residents and an area of more than 5,000 square miles shall receive \$4.00 per day, including Sundays, for attendance in district court, and ten cents for each mile traveled in going to and returning from court, the distance to be computed by the usually traveled route, and to be paid out of the county treasury. The clerk of the district court shall deliver to each juror a certificate for the number of days attended and the number of miles traveled to which he is entitled as compensation. Talesmen actually serving upon any petit jury shall receive the sum of \$4.00 per day also.

Sec. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 193—H. F. No. 500

*An act to amend Laws 1921, Chapter 437, as amended by Laws 1927, Chapter 225, as amended by Laws 1931, Chapter 192, as amended by Laws 1933, Chapter 284, fixing the salaries and compensation of county officers and their expenses and clerk hire in all coun-*
