CHAPTER 33-S. F. No. 99

An act relating to the form of certificate of title given by the registrar of titles, and amending Mason's Minnesota Statutes of 1927, Section 8281.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Law amended.—Mason's Minnesota Statutes of 1927, Section 8281, is hereby amended so as to read as follows:

"8281. Form of certificate.—The certificate of title shall contain the name and residence of the owner, a description of the land, and of the estate of the owner therein, and shall by memorial contain a description of all encumbrances, liens and interests in which the estate of the owner is subject. It shall state his age, and if under disability the nature thereof. It shall also state whether or not the owner is married, and, if married, the name of the husband or wife. In case the land is held in trust or subject to any condition or limitation, it shall state the nature and character thereof. It shall be substantially in the following form:

- (3) Any lease for a period not exceeding three years, when there is actual occupation of the premises under the lease:
- (4) All public highways embraced in the description of the lands included in the certificates shall be deemed to be excluded:
- (5) Such right of appeal or right to appear and contest the application as is allowed by law;
- (6) The rights of any person in possession under deed or contract for deed from the owner of the certificate of title.
