Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1909, Chapter 361, Sections 2 and 4, as amended by Laws 1913, Chapter 203, as amended by Laws 1915, Chapter 137, as amended by Laws 1917, Chapters 481 and 510, as amended by Laws 1919, Chapter 304, Section 4, as amended by Laws 1921, Chapter 336, Section 4, as amended by Laws 1923, Chapter 307, Section 3, as amended by Laws 1929, Chapter 317, as amended by Laws 1931, Chapter 258, Section 4, is hereby amended to read as follows:

"Sec. 4. Sheriff of Ramsey County to appoint certain assistants. In any county, in which any such sheriff may be in charge of the county jail, he shall appoint a matron thereof, and two assistant matrons, one chief jailer, and seven assistant jailers, and the said chief jailer and each of said assistants shall also be deputies; and two utility jail deputies, one of whom shall be a female, to perform such duties as the sheriff may direct."

#### CHAPTER 175—H. F. No. 776

*An act relating to aeronautics, authorizing municipalities and other political subdivisions of adjoining states to acquire and operate airports, restricted landing areas, and other air navigation facilities in this state, conditioned upon the reciprocal grant of authority to municipalities and other political subdivisions of this state.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Municipalities in adjoining states may acquire air navigation facilities in state.** Subdivision 1. The governing body of any county, city, village, town, or other municipality or political subdivision of an adjoining state, whose laws permit, is hereby authorized to acquire, establish, construct, own, control, lease, equip, improve, maintain, and operate airports, or restricted landing areas, or other air navigation facilities in this state, subject to all laws, rules,

and regulations of this state applicable to its municipalities and other political subdivisions in such aeronautical projects, but subject to the laws of its own state in all matters relating to financing such projects.

Subd. 2. **To have same rights as local municipalities.** Such municipality or other political subdivision of an adjoining state shall have all the rights, privileges, and duties of like municipalities and political subdivisions of this state, including the right to exercise the right of eminent domain.

Subd. 3. **Reciprocal provisions.** This act shall not apply unless the laws of such adjoining state shall permit municipalities and other political subdivisions of this state to acquire, establish, construct, own, control, lease, equip, improve, maintain, operate, and otherwise control such airports, restricted landing areas, or other air navigation facilities therein, with all privileges, rights, and duties applicable to the municipalities and other political subdivisions of such adjoining state in such aeronautical projects.

#### CHAPTER 176—H. F. No. 778

*An act relating to an advisory seed potato certification committee, amending Minnesota Statutes 1941, Sections 21.12 and 21.16.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1941, Section 21.12, is amended to read as follows:

"21.12. **Duties of commissioner; employees.** The Commissioner is hereby authorized and it is made his duty to provide the means and direct the work for the inspection, certification, promotion of quality, and creation of demand and sale of seed potatoes. He shall provide such forms as are necessary and keep a record of the work performed, and shall appoint, designate, or employ such officers, inspectors, and employees as may be deemed necessary and fix their compensation.
