

CHAPTER 103—H. F. No. 294
[Section 2 coded as Section 109.38]

An act repealing Minnesota Statutes 1945, Chapter 109, relating to town ditches but saving powers relating to repairs thereon.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Repealed.** Minnesota Statutes 1945, Chapter 109, is hereby repealed save only as to unfinished proceedings instituted under said chapter and not completed at the date of this act. Any proceedings so instituted and incomplete at the date of the passage of this act may be completed under the provisions of the laws under which the same were instituted; and for such purpose the provisions of such laws shall continue and apply to such proceedings.

[109.38] Sec. 2. **Repair of town ditches.** The town board of any town in which is located a town ditch shall have the same powers to repair such town ditch as are conferred upon the board of county commissioners to repair county ditches.

Sec. 3. **Effective date.** This act shall take effect and be in force from and after its passage.

CHAPTER 104—H. F. No. 452

An act relating to the manufacture and sale of butter; amending Minnesota Statutes 1945, Section 32.31, and repealing Minnesota Statutes 1945, Section 32.39.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1945, Section 32.31, is amended to read:

32.31. **Butterfat content of butter.** No person shall manufacture for sale, or sell, or have in possession with intent to sell, any dairy or creamery butter which contains less than 80 per cent butterfat by weight, *or which has been manufactured from milk or cream which has not been pasteurized in accordance with the provisions of Sections 32.391 and 32.392.*

Sec. 2. **Repealed.** Minnesota Statutes 1945, Section 32.39, is repealed.

Sec. 3. **Effective date.** This act shall become effective July 1, 1948.

CHAPTER 105—S. F. No. 411

[Coded as Section 161.03, Subdivision 22]

An act relating to the state highway patrol; amending Minnesota Statutes 1945, Section 161.03, Subdivision 22.

Be it enacted by the Legislature of the State of Minnesota :

Section 1. Minnesota Statutes 1945, Section 161.03, Subdivision 22, is amended to read as follows :

[161.03] **Powers of commissioner of highways. Subd. 22. Fines paid into separate funds; how used.** All fines and forfeited bail money, from traffic and motor vehicle law violations, collected from persons apprehended or arrested by such employees, shall be paid into the state treasury by the justice of the peace, or such other person or officer collecting such fines, forfeited bail money or instalments thereof, within 15 days after the last day of the month in which such moneys were collected, and shall be credited to a separate fund hereby established for that purpose. Out of such fund shall first be paid to counties all costs and expenses incurred by them in the prosecution and punishment of persons so arrested and for which such counties have not been reimbursed by the payment of such costs and expenses by the person prosecuted, and so much of the fund as shall be necessary for the making of such reimbursement is hereby appropriated therefor. Such payment shall be made by the state treasurer upon the claim of the county verified by the county auditor *but no claim shall be made exceeding \$1.50 per day for board and lodging of a prisoner.* On the first day of each calendar month the money remaining in such fund shall be credited to that part of the trunk highway fund which is set apart for maintenance purpose; and so much of the maintenance fund as shall be necessary for the salaries and maintenance of such employees is hereby appropriated for that purpose.
