

Sec. 7. Subd. 7. Live stock sanitary board to make rules and regulations. The State Live Stock Sanitary Board shall have the power to adopt such rules and regulations, not inconsistent with this act, as may be necessary to carry out the provisions of this act, and shall have the right whenever it deems advisable, or in the public interest, to inspect or investigate any institution which has applied for a license or has been granted a license hereunder.

Sec. 8. Subd. 8. Violations and penalties. It shall be a misdemeanor for any person or corporation to violate any of the provisions of this act.

CHAPTER 196—S. F. No. 849

An act amending Minnesota Statutes 1945, Section 32.01; amending Laws 1947, Chapter 396, relating to the authority of the commissioner of agriculture, dairy and food to adopt standards, definitions and grades for dairy products; and repealing Minnesota Statutes 1945, Sections 32.02, 32.03, 32.04, 32.05, 32.06, 32.07, 32.50 Subdivision 4, and 32.51 Subdivision 3.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1945, Section 32.01, is amended as follows:

32.01. Definitions. Subdivision 1. Unless the language or context clearly indicates that a different meaning is intended, the *words defined in this section shall, for the purposes of this chapter, be given the meanings subjoined to them.*

Subd. 2. "Commissioner" means the commissioner of agriculture, dairy and food.

Subd. 3. "Department" means the department of agriculture, dairy and food.

Subd. 4. "Person" means an individual, firm, partnership, association, or corporation.

Subd. 5. "Cream-buying station" means any place other than a creamery where deliveries of cream are weighed, sampled, or tested for purchase on a butterfat basis.

Subd. 6. "Creamery" means any place where cream, delivered by two or more persons, is churned into butter for commercial purposes.

Subd. 7. "Babcock test" means the official Babcock test for milk and cream as set forth in section 32.25.

Subd. 8. "Overrun" is the difference between the weight of any given amount of pure butterfat and the weight of the butter manufactured therefrom; and this difference, ascertained in any case, divided by the given amount of pure butterfat in such case and multiplied by 100, is the "percentage of overrun" in the manufacture of butter.

Sec. 2. Laws 1947, Chapter 396, is amended as follows:

[32.491] Section 1. **Milk standards; enforcement. Subdivision 1. Commissioner shall adopt standards and grades; hearings.** In order to protect the public health and welfare, to promote the interests of the dairy industry in Minnesota, and to secure uniformity, the commissioner of agriculture, dairy and food shall adopt standards and grades for milk *and cream* purchased for manufacturing purposes. Before adopting any standards or grades for milk *and cream*, the commissioner shall hold a public hearing thereon, as provided by law.

Sec. 2. **Subd. 2. Purchases based on grades.** All milk *and cream* purchased for manufacturing purposes shall be purchased on the basis of the standards and grades so adopted.

Sec. 3. **Subd. 3. Enforcement.** The commissioner of agriculture, dairy and food shall enforce the provisions of this act and shall have all the power and authority granted him under Laws 1941, Chapter 495, as amended.

Sec. 4. **Subd. 4. Penalties.** Any person, firm, or corporation violating any of the provisions of this act shall be guilty of a misdemeanor.

Sec. 3. **Repealer.** Minnesota Statutes 1945, Sections 32.02, 32.03, 32.04, 32.05, 32.06, 32.07, 32.50 Subdivision 4 and 32.51 Subdivision 3 are repealed.
