- (c) Fish peddler's license to peddle fish with the use of a motor vehicle, within the state only, \$5.00;
- (6) To tan or dress raw furs, \$2.00.

It shall be unlawful to use, in harvesting wild rice in any public waters in this state, any water craft other than a boat, skiff, or canoe propelled by hand, which boat, skiff, or canoe may have a top width of not more than 36 inches and a length of not more than 16 feet, or any machine or mechanical device for gathering or harvesting the grain other than with flails not over 30 inches in length nor over one pound in weight, which flails must be held and operated by hand.
- [98.46] Sec. 4. Harvesting hours. Subd. 9. It shall be unlawful to harvest any wild rice grain between the hours of six p.m. and eight a.m. of the day following; nor shall any rice pole be used for propelling boats used in the harvesting of wild rice grain which is not forked at the end, with each fork less than 12 inches in length.

CHAPTER 507—H. F. No. 773

An act relating to employments licensed by state boards; amending Minnesota Statutes 1945, Section 326.10, Subdivisision 1.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. Minnesota Statutes 1945, Section 326.10, Subdivision 1, is amended to read:
- 326.10. Certificates of registration. Subdivison 1. Issuance. The board shall, on application therefor, on a prescribed form, and the payment of a fee not to exceed \$10, issue a certificate of registration as an architect or engineer,

and, on the payment of a fee of not to exceed \$5.00, issue a certificate of registration as a land surveyor;

To any person over 25 years of age, who is a citizen of the United States or Canada, or who has made declaration of his intention to become a citizen of the United States; who speaks and writes the English language; who is of good moral character and repute, and has been actively engaged for eight or more years in architectural or engineering work. or engaged for six or more years in surveying work. The character of such work shall be satisfactory to the Board. Each scholastic year of teaching or of study satisfactorily completed. of architecture, engineering, or land surveying in a school or college of architecture or engineering accredited by the National Architectural Accrediting Board or by the Engineers' Council for Professional Development, shall be considered as equivalent to one year of such active engagement, provided, however, that three years of actual experience of a standard satisfactory to the board shall be required in addition to school attendance.

An honorably discharged veteran of World War I or World War II shall be given credit for such experience or education gained in the armed services of the United States as meets the standards fixed by the board.

- (2) To any person who holds a like unexpired certificate of registration issued to him by proper authority in the District of Columbia, in any state or territory of the United States, or in any province of Canada, in which the requirements for registration of architects, engineers, or land surveyors are equal to those fixed by the board and by the laws of this state, and in which similar privileges are extended to the holders of certificates of registration issued by this state;
- (3) A certificate of registration as an architect shall be issued without the examination provided for in subdivision 2 upon the payment of the fee set forth in subdivision 1 to any person over 45 years of age who is a citizen of the United States or Canada, who speaks and writes the English language, who is of good moral character and repute, who is an honorably discharged veteran of World War I or World War II, who has at least five quarters in study in a school or college of architecture accredited by the National Architectural Accrediting Board, who has had at least eight years experience in the

drafting of plans for small residential units and the construction thereof, and who has for at least eight years served in the mechanical department of a common carrier in the United States or a major industrial plant therein.
