

## CHAPTER 186—H. F. No. 159

*An act relating to the compensation paid sheriffs for boarding prisoners; amending Minnesota Statutes 1945, Section 641.11, as amended.*

Be it enacted by the Legislature of the State of Minnesota :

Section 1. Minnesota Statutes 1945, Section 641.11, as amended by Laws 1947, Chapter 38, Section 1, is amended to read :

641.11. **Compensation for boarding prisoners.** Every sheriff in charge of a county jail shall receive from the county compensation for board and washing of prisoners as follows :

On the last day of each month he shall render to the county board a verified statement showing the name of each prisoner and the number of days boarded. The pay shall be \$1.50 *for each day or fractional day* for each prisoner. In every county where the sheriff's compensation for board of prisoners is fixed by special law it shall so continue unless the county board by unanimous vote shall elect to come under the general law after which it shall be governed by this section provided that the provisions of this section shall not apply to any county in this state now or hereafter having a population of more than 75,000.

CHAPTER 187—H. F. No. 772

[Coded as Section 48.515]

*An act relating to the collection, payment and dishonor of demand items by banks and the revocation of credit for, and payment of, such items.*

Be it enacted by the Legislature of the State of Minnesota :

[48.515] Section 1. **Deposit of demand items; time credited.** Subdivision 1. **Time credit or dishonor.** In any case in which a bank receives, other than for immediate pay-

ment over the counter, a demand item payable by, at or through such bank and gives credit therefor before midnight of the day of receipt, the bank may have until midnight of its next business day after receipt within which to honor or refuse payment of such item. Any credit so given together with all related entries on the receiving bank's books, may be revoked by returning the item, or if the item is held for protest or at the time is lost or is not in the possession of the bank, by giving written notice of dishonor, nonpayment, or revocation; provided that such item or notice is dispatched in the mails or by other expeditious means not later than midnight of the bank's next business day after the item was received. For the purpose of determining when notice of dishonor must be given or protest made under the law relative to negotiable instruments, an item duly presented which is dishonored or credit for which is revoked as authorized by this Act, shall be deemed dishonored on the day the item or notice is dispatched. A bank, revoking credit pursuant to the authority of this Act, is entitled to refund of, or credit for, the amount of the item.

**Sec. 2. Subd. 2. Deposit after regular hours; credit; branch office.** For the purposes of this Act:

(1) An item received by a bank on a day other than its business day, or received on a business day after its regular business hours or during afternoon or evening periods when it has reopened or remained open for limited functions, shall be deemed to have been received at the opening of its next business day;

(2) The term "credit" includes payment, remittance, advice of credit or authorization to charge and, in cases where the item is received for deposit as well as for payment, also includes the passing of appropriate entries to the receiving bank's general ledger without regard to whether the item is posted to individual customers' ledgers;

(3) Each branch or office of a bank shall be deemed a separate bank.

**Sec. 3. Subd. 3. Variation by agreement.** The effect of this Act may be varied by agreement.
