

Be it enacted by the Legislature of the State of Minnesota :

Section 1. Minnesota Statutes 1945, Section 448.09, is amended to read :

448.09. **Cities of the second or third class may acquire lands for parks and parkways.** Any city of the second or third class *may* receive as a gift or donation, in whole or in part, and acquire through its board of park commissioners lands within *its* corporate limits, and thereafter hold, control, lay out, alter, improve, operate, and maintain these lands for public parks and parkway (s). *This* control, improvement, and maintenance shall cover all park lands heretofore acquired by the city.

CHAPTER 278—H. F. No. 566

An act repealing Minnesota Statutes 1945, Sections 23.01 to 23.14, relating to co-operative credit associations of corporations.

Be it enacted by the Legislature of the State of Minnesota :

Section 1. **Repeal.** Minnesota Statutes 1945, Sections 23.01 to 23.14, are repealed.

CHAPTER 279—H. F. No. 567

An act relating to the cancelation of the registration of Chiropodists; amending Minnesota Statutes 1945, Section 153.07.

Be it enacted by the Legislature of the State of Minnesota :

Section 1. Minnesota Statutes 1945, Section 153.07, is amended to read :

153.07. **Cancelation of registration.** The board after hearing may by majority vote revoke any certificate issued by it and cancel the registration of any chiroprapist who has been convicted of violation of the provisions of section 153.08. The board may after hearing by majority vote revoke the certificate and cancel the registration of any person when the court records of any state or territory within the United States, or the federal court records, or the record of any court of jurisdiction in any foreign country, show that such person has been found guilty of a criminal offense. The board may after hearing by majority vote revoke the certificate and cancel the registration of any person whose registration was granted upon mistake of material fact. The board may subsequently, but not earlier than one year thereafter, by unanimous vote, reissue any certificate and register anew any chiroprapist whose certificate was revoked and whose registration was canceled by the board.

CHAPTER 280—H. F. No. 568

An act to repeal Minnesota Statutes 1945, Section 513.02, relating to the auctioneer's memorandum of sale at a public sale of goods.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Repeal.** Minnesota Statutes 1945, Section 513.02, is hereby repealed.
