CHAPTER 55—H. F. No. 278

An act relating to county employees and their compensation in counties having a population of more than 300,000 and less than 450,000 inhabitants; amending Laws 1943, Chapter 2, Section 1.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1943, Chapter 2, Section 1, is amended to read:

Section 1. **Definition.** When used in this act the following words and phrases have the meaning ascribed to them in this section:

(1) County government means all officers and agencies of the county.

(2) County means any county *having more than 300,000 and less than 450,000 inhabitants.*

CHAPTER 56—H. F. No. 279

An act relating to deputies and clerical help of the sheriff and providing automobile and other expenses, in counties having more than 300,000 and less than 450,000 inhabitants; amending Laws 1947, Chapter 457, Section 1.

Be it enacted by the Legislature of the State of Minnesota :

Section 1. That Laws 1947, Chapter 457, Section 1, be amended to read :

Section 1. **Ramsey county; appointment of deputy sheriffs.** The sheriff in any county having *more than 300,000 and less than 450,000* inhabitants shall appoint and employ one chief deputy, one chief criminal deputy and two assistants, ten court bailiffs, one chief patrol deputy and ten assistants, one female deputy, four process servers, one chief jailer and eight assistants, one matron and three assistants, one book-keeper-cashier, one principal clerk, two clerk-stenographers and one senior clerk-typist. Five of said patrol deputies shall furnish their own automobile or motorcycle for the patrolling of the county districts and shall receive the sum of \$35.00 per month for the care, maintenance and operation of said automobile or motorcycle. The titles herein mentioned shall not be controlling but shall be subject to change by the county board or other lawful authority.

CHAPTER 57—H. F. No. 280

An act relating to the chief deputy and employees of the county assessor in counties having a population of more than 300,000 and less than 450,000 inhabitants; amending Minnesota Statutes 1945, Section 391.02.

Be it enacted by the Legislature of the State of Minnesota :

Section 1. Minnesota Statutes 1945, Section 391.02, is amended to read :

391.02. County assessor and deputies in Ramsey county. In any county, having *more than 300,000 and less than 450,000* inhabitants, the county assessor shall appoint and employ one chief deputy.

The county board shall by resolution authorize the county assessor to employ such additional deputies, clerks, field men, appraisers, or employees as it may deem necessary for the proper performance of the duties of the office of county as-
