for the purpose of making the transfers provided for by Subdivision 1 of this section and thus reducing the amounts to be raised by the tax levies provided for by Section 1 of this act, until after the date prescribed for the making of the last of those levies, or until they are otherwise canceled by law.

Sec. 7. Subd. 7. Supplementary appropriation. The appropriation to the governor made by Section 4 is in addition to any other appropriation made to him out of the Minnesota Aeronautics Fund by any other statute.

Sec. 8. Subd. 8. **Designated appropriation.** Of the moneys hereby appropriated to the governor, \$150,000 may upon his authorization, be made available to the Minneapolis-St. Paul Metropolitan Airports Commission to be used for the purpose of constructing and improving a major airport at the Anoka County site.

CHAPTER 609-H. F. No. 735

An act relating to the department of insurance, and amending Minnesota Statutes 1945, Section 172.06.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1945, Section 172.06, is amended to read as follows:

172.06. **Retirement fund.** There is hereby created the highway patrolmen's retirement fund and all moneys received under the provisions of Laws 1943, Chapter 637, shall be credited to said fund. In addition thereto, 66 per cent of all moneys heretofore paid by any highway patrolman into the state employees' retirement fund is hereby appropriated therefrom and credited to the fund hereby created. The state treasurer shall, upon the passage of Laws 1943, Chapter 637, ascertain the amount heretofore paid by highway patrolmen as aforesaid and transfer the amount so paid to the fund hereby created. The public examiner shall audit the fund in the course of his examination of the highway department records

and the officers of the fund shall biennially have made an actuarial study of the fund, the cost of which shall be borne by the fund. Reports on the actuarial survey shall be furnished to the legislature.

CHAPTER 610-H. F. No. 1000

[Not Coded]

An act fixing the salaries of county commissioners in counties now or hereafter having a population of not less than 39,500 and not more than 42,000 and having an assessed valuation of not less than \$19,000,000.00 and not more than \$25,-000,000.00 and containing within its boundaries a city of the third class.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Salaries of county board in certain counties. In each county of this state, now or hereafter having a population of not less than 39,500 and not more than 42,000, and having an assessed valuation of not less than \$19,000,000.00 and not more than \$25,000,000,00 and containing within its boundaries a city of the third class, the salaries of the county commissioners shall be \$1,500.00 per year, payable in equal monthly installments.

Sec. 2. Payment validated. Any payments heretofore made in any such counties are hereby validated and approved.

Sec. 3. Effective date. This act shall take effect and be in force thirty days from and after its passage.
