CHAPTER 60—S. F. No. 643

*An act relating to policemen's relief associations in certain cities of the third class; amending Minnesota Statutes 1949, Section 423.392.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1949, Section 423.392, is amended to read:

**423.392. Police relief associations; application of section.** The provisions of section 423.37 shall apply to and bind any city of the third class which by a resolution of its governing body, adopted by a majority of the members thereof shall choose to be bound by it, *and such city may thereafter continue to be bound by it notwithstanding a subsequent change in the classification of the city*; but section 423.37 does not apply to any policemen's relief association in existence at the time of the passage of this act unless the association elects to come under its provisions as herein provided.

CHAPTER 61—H. F. No. 107

*An act relating to a certain state forest, amending Minnesota Statutes 1949, Section 89.021, enumeration 23, affecting the Sand Dunes State Forest only.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1949, Section 89.021, enumeration 23, is amended to read:

89.021 (23) Sand Dunes State Forest. *All of Sections 13, 14, 15, 16, 17, 20, 21, 22, 23, 24, 25, 26, 27, 28, 29, 35 and 36, all in Township 34, Range 27; west of the 4th principal meridian.*

CHAPTER 62—H. F. No. 129

*An act relating to wild animals and to the establishment of game refuges; amending Minnesota Statutes 1949, Section 99.25, Subdivision 5.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1949, Section 99.25, Subdivision 5, is amended to read:

Subd. 5. No game refuge of less than 640 acres of contiguous lands and water shall be established under any of the provisions of subdivisions 2, 3, and 4; *provided, that upon petition subscribed by either the owner, the lessee, or the person in possession of each tract in the area a game refuge of lesser area may be established bordering on or including a lake, stream, pond, marsh or other body of water or water-course found suitable for wild life habitat.*

CHAPTER 63—H. F. No. 228

[Coded as Sections 471.71 to 471.83]

*An act relating to the financial affairs of certain cities, villages, towns, and school districts more than 50 per cent of the assessed valuation of which consists of iron ore, prescribing penalties for violation of its provisions; amending Laws 1943, Chapter 526; and repealing Laws 1929, Chapter 303; Laws 1931, Chapter 342; Laws 1933, Chapters 210, 275, and 415; and Laws 1935, Chapter 261, in part.*
