CHAPTER 60-H. F. No. 166

An act relating to motor vehicles, the regulation, registration and taxation thereof; amending Minnesota Statutes 1953, Section 168.013, Subdivision 8; Section 168.057 and Section 168.231.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. Minnesota Statutes 1953, Section 168.013, Subdivision 8, is amended to read:
- Subd. 8. Proceeds to highway user tax distribution fund. The proceeds of the tax imposed on motor vehicles under this chapter shall be collected by the registrar of motor vehicles and paid into the state treasury and credited to the highway user tax distribution fund.
- Sec. 2. Minnesota Statutes 1953, Section 168.057, is amended to read:
- 168.057 Fees credited to highway user tax distribution fund. All fees derived from sections 168.053 to 168.057 shall be paid into the state treasury and credited to the highway user tax distribution fund.
- Sec. 3. Minnesota Statutes 1953, Section 168.231, is amended to read:
- 168.231 Tax proceeds credited to highway user tax distribution fund. The proceeds of the tax imposed under the provisions of sections 168.181 to 168.231 shall be collected by the registrar of motor vehicles and paid into the state treasury and credited to the highway user tax distribution fund.
 - Sec. 4. This act takes effect on July 1, 1957.

CHAPTER 61—H. F. No. 248

An act relating to the post-audit of the financial affairs of the state agricultural society by the public examiner; amending Minnesota Statutes 1953, Section 37.06.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. Minnesota Statutes 1953, Section 37.06, is amended to read:
 - 37.06 Secretary; public examiner; duties; report. The

secretary shall keep a complete record of the proceedings of the annual meetings of the state agricultural society and all meetings of the governing board, and of any committee of the board, keep all accounts of the society and perform such other duties as the governing board may direct. On or before December 15th, each year, the secretary shall make a report to the governor for the fiscal year ending November 30th each year, showing all the proceedings of the society during the current year, and its financial condition as appears from the books of the society. This report shall contain a full, detailed statement of all receipts and expenditures during the year. The books and accounts of the society for the fiscal year shall be examined and audited annually by the public examiner, if funds and personnel permit, and a full, detailed report thereof made to the governor. A summary of this examination, duly certified by the public examiner, together with his recom-mendations and the proceedings of the annual meeting of the society first held following the secretary's report, including such addresses made at the meeting as the governing board shall direct, shall be appended to the secretary's report and printed in like manner as the reports of state officers. Four thousand copies of the report shall be printed annually and distibuted as follows: three copies to each society or association entitled to membership in the society, one copy to each newspaper in the state, and the remaining copies in such manner as the governing board shall direct. The unpaid claims for examination heretofore made by the board of audit shall be paid from the funds of the society upon allowance by the governing board.
