

CHAPTER 31—S. F. No. 166

An act relating to highway traffic regulations; amending Minnesota Statutes 1957, Section 169.06, Subdivision 6.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1957, Section 169.06, Subdivision 6, is amended to read:

Subd. 6. **Pedestrian signals.** When special pedestrian-control signals exhibiting the words "Walk", "*Don't Walk*", or "Wait" are in place such signals shall indicate as follows:

(a) A ~~Pedestrian~~ *pedestrian* facing a "Walk" signal may proceed across the roadway in the direction of the signal and shall be given the right-of-way by the drivers of all vehicles.

(b) No pedestrian shall start to cross the roadway in the direction of a "Wait" or "Don't Walk" signal, but any pedestrian who has partially completed his crossing on the "Walk" signal shall proceed to a sidewalk or safety island while the "Wait" or "Don't Walk" signal is showing.

CHAPTER 32—S. F. No. 196

An act relating to drivers licenses; amending Minnesota Statutes 1957, Section 171.17.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1957, Section 171.17, is amended to read:

171.17 **Revocation, drivers license.** The department shall forthwith revoke the license of any driver upon receiving a record of such driver's conviction of any of the following offenses:

- (1) Manslaughter or criminal negligence resulting from the operation of a motor vehicle;
- (2) Operating a motor vehicle while under the influence of intoxicating liquor or narcotic drug;
- (3) Any felony in the commission of which a motor vehicle was used;

(4) Failure to stop and disclose identity and render aid, as required under the laws of this state, in the event of a motor vehicle accident resulting in the death or personal injury of another;

(5) Perjury or the making of a false affidavit or statement to the department under any law relating to the ownership or operation of a motor vehicle;

(6) Conviction, plea of guilty, or forfeiture of bail not vacated, upon three charges of careless or reckless driving, or illegal speeding committed within a period of 12 months;

(7) Conviction of an offense in another state which, if committed in this state, would be grounds for the revocation of the driver's license;

When any judge of a juvenile court, or any of its duly authorized agents, shall determine, formally or informally, that any person under the age of 18 years has committed any offense defined in this section, such judge, or duly authorized agent, shall immediately report such determination to the department, and the commissioner shall immediately revoke the license of that person.

Upon revoking the license of any person, as hereinbefore in this chapter authorized, the department shall immediately notify the licensee, in writing, by depositing in the United States post-office a notice addressed to the licensee at his last known address, with postage prepaid thereon.
