An act authorizing the commissioner of conservation to sell certain school lands.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **State land, sale of, Scott county.** The commissioner of conservation is hereby authorized to sell lot 1 in section 24 of township 113, range 23, in Scott county, in the manner provided by law for the sale of state public lands, notwithstanding the fact that such lands border a public, meandered lake.

An act relating to highway traffic regulations and authorized emergency vehicles; repealing Laws 1959, Chapter 66, Section 2.

Be it enacted by the Legislature of the State of Minnesota:

CHAPTER 167—H. F. No. 525

An act authorizing the conveyance of certain real estate owned by the state to the city of Virginia.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. State land, conveyance to city of Virginia. Notwithstanding any law to the contrary, the Governor, upon the recommendation of the commissioner of highways, shall transfer and convey by proper deed of conveyance in the name of and on behalf of the state of Minnesota, to the city of Virginia, a municipal corporation, in the county of St. Louis, for public purposes, all or any portion of the following described real estate situated in St. Louis county, Minnesota, to-wit:

The south 333.0 feet of the southeast quarter of the southwest quarter (SE 1/4 SW 1/4) of section 6, township 58 north, range 17 west, excepting therefrom the east 250 feet, the west 450 feet and the south 83 feet thereof; containing 3.41 acres, more or less. Together with the west 100 feet of the east 250 feet of the north 300 feet of the south 333 feet of the southeast quarter of the southwest quarter (SE 1/4 SW 1/4) of section 6, township 58 north, range 17 west; containing 0.69 acre, more or less.

Sec. 2. The consideration to be paid by the City of Virginia to the state of Minnesota for any real estate conveyed hereunder shall be in such amount as may be mutually agreed upon by the city and the commissioner of highways.
