## CHAPTER 249-S. F. No. 798

## [Not Coded]

An act relating to the salaries of the county commissioners of Dakota county.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Dakota county, commissioners' salaries. The yearly salaries of the members of the board of county commissioners of Dakota county shall be set by said board at a sum not to exceed \$4,800, which sum shall be payable in equal monthly installments.

Sec. 2. Dakota county, commissioners' expense. Each member of the board of county commissioners shall be allowed a sum not to exceed \$600 per year, which said sum shall be payable in equal monthly installments as and for expense account.

Sec. 3. The salary and expense provided in sections 1 and 2 shall be in lieu of all other emoluments, per diems, or mileage now allowed by law, except the per diem and expense allowed as a member of the Dakota county welfare board.

Sec. 4. This act shall become effective only after its approval by a majority vote of the board of county commissioners of Dakota county and upon compliance with Laws 1959, Chapter 368.

CHAPTER 250—S. F. No. 829

[Coded in Part]

An act relating to municipal courts; fixing thhe salary of a judge and special judge of the municipal court of Hastings when such court is established.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Subdivision 1. When and if a municipal court is established in the city of Hastings pursuant to Laws 1959, Chapter 660, the salaries of the judge and special judge shall be as herein provided.

Subd. 2. The annual salary of the judge of the municipal court in the city of Hastings is \$5500.

Subd. 3. The salary of any special judge of such municipal court is as provided in Laws 1959, Chapter 691.

Subd. 4. Such municipal court is subject to the provisions of Laws 1959, Chapter 691, to the extent applicable.

Sec. 2. [482.30] Hastings municipal court. When the court referred to in section 1 is established, the revisor of statutes in compiling Minnesota Statutes shall add the city of Hastings and the salary of the judge fixed in section 1, subdivision 2, hereof, to Laws 1959, Chapter 691, Section 1, Subdivision 2.

## CHAPTER 251-S. F. No. 897

## [Coded]

An act relating to the establishment of ordinance violations bureaus in cities, villages, and boroughs to assist the courts in disposing of certain ordinance violations.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. [493.01] Establishment; service of notice of violation. Subdivision 1. The council of any city, however organized, or of any village or borough may by ordinance authorize the court or courts in that municipality to establish an ordinance violations bureau to assist the court in disposing of violations of ordinances relating to building construction, operation, or maintenance; fire and fire prevention; public health and sanitation; and zoning.

Subd. 2. The ordinance and court rule or rules establishing such a bureau shall contain the provisions and shall be adopted and amended in the manner provided in Minnesota Statutes 1957, Sections 492.01 to 492.03, and acts amendatory thereof relating to traffic violations bureaus, except that for purposes of this act the references to traffic offenses or traffic violations in these sections shall mean violations of the ordinances enumerated in subdivision 1 of this act. The ordinance shall also confer upon the building inspector, the health officer, and such other qualified officers and
