CHAPTER 354—S. F. No. 946

*An act relating to terms of district court in certain counties; amending Minnesota Statutes 1957, Section 484.09, as amended.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1957, Section 484.09, as amended by Laws 1959, Chapter 249, Section 1, is amended to read:

484.09 **Dakota and Goodhue counties.** General terms of district court in the counties named in this section shall be held each year at the time herein specified:

Dakota County: The second Monday in January, the first Monday in April, and the ~~second~~ *third* Monday in ~~November~~ *September*.

Goodhue County: The second Monday in February, the second Monday in May, and the first Monday in October.

Sec. 2. *This act takes effect on July 1, 1961.*

*An act authorizing the county of Sibley to expend moneys to erect or aid in erecting a monument or memorial to war veterans.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Sibley county; war veterans memorial.** The board of county commissioners of the county of Sibley may expend moneys to erect or aid in erecting a monument

or memorial to the war veterans of Sibley county, to be erected and maintained in Winthrop, Minnesota.

CHAPTER 356—S. F. No. 1163

*An act relating to salaries of members of the county board of commissioners of Itasca county; amending Laws 1959, Chapter 352, Section 1; repealing Laws 1959, Chapter 352, Section 2.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1959, Chapter 352, Section 1, is amended to read:

Section 1. **Itasca county, commissioners' salaries.** Notwithstanding the provisions of any other law to the contrary, each member, *except the chairman*, of the board of county commissioners of the county of Itasca shall receive a monthly salary of ~~\$315~~ \$400 payable on the first day of each calendar month as the salaries of other county officials are paid. *The chairman of the board of county commissioners shall receive a monthly salary of \$425 payable in the same manner as other board members' salaries are paid.*

Sec. 2. *Laws 1959, Chapter 352, Section 2, is hereby repealed.*

Sec. 3. *Section 1 is effective upon its approval by a majority of the members of the board of county commissioners of Itasca county and upon compliance with Laws 1959, Chapter 368.*
