## CHAPTER 49—H. F. No. 370

An act relating to the league of Minnesota municipalities and the membership of certain towns therein; amending Minnesota Statutes 1957, Section 465.58.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1957, Section 465.58, is amended to read:

465.58 League of municipalities. Any city, village, or borough of this state, whether organized under the general laws or a special or home rule charter, or any town having the powers of a village under section 368.01, may appropriate through its governing body council or town board, out of its general fund, money to pay the annual dues in the League of Minnesota Municipalities and the actual and necessary expenses of such delegates as such governing body council or town board may designate to attend meetings of any such the league.

## CHAPTER 50—S. F. No. 422

An act relating to potato development; defining certain administrative areas; amending Minnesota Statutes 1957, Section 21.36, Subdivision 1.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1957, Section 21.36, Subdivision 1, is amended to read:

21.36 Potato development areas. Subdivision 1. For the purpose of administration of sections 21.32 to 21.46 the state is divided into four areas. Area number one includes all of the ninth congressional district as it existed before any congressional redistricting occurring after the 1960 federal census except the counties of Roseau, Lake of the Woods, Beltrami, and Clearwater. Area number two includes all of the eighth congressional district as it existed before any congressional redistricting occurring after the 1960 federal census and, in addition thereto, the counties of Roseau, Lake of the Woods, Clearwater, and Beltrami. Area number three includes all of congressional districts one, two, and seven as

they existed before any congressional redistricting occurring after the 1960 federal census. Area number four includes all of the remainder of the state.

## CHAPTER 51—S. F. No. 63

An act providing counties with authority to issue bonds for the acquisition or betterment of library buildings; amending Minnesota Statutes 1957, Section 475.52, Subdivision 3.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. Minnesota Statutes 1957, Section 475.52, Subdivision 3, is amended to read:
- Subd. 3. Counties, library bond issue. Any county may issue bonds for the acquisition or betterment of courthouses, jails, poor farms, morgues, libraries, and hospitals, for roads and bridges within the county or bordering thereon and for road equipment and machinery, except that the power of counties to issue bonds in connection with a library shall not exist in a county containing a city of the first class of over 300,000 according to the 1960 United States census.

## CHAPTER 52—S. F. No. 266

An act relating to game and fish, authorizing the commissioner to issue special permits to handicapped persons; amending Minnesota Statutes 1957, Section 98.48, by adding a subdivision.

Section 1. Minnesota Statutes 1957, Section 98.48, is amended by adding a subdivision to read:

[98.48] Subd. 12. Hunting licenses, physically handicapped persons. The commissioner may issue special permits, without fee, to shoot or hunt from a standing vehicle, to licensed hunters who after investigation are found to be paraplegics or otherwise physically unable to walk; pro-
