

## CHAPTER 691—H. F. No. 1430

*An act relating to the state employees retirement association; amending Minnesota Statutes 1961, Section 352.03, Subdivision 4, as added by Laws 1963, Chapter 383, Section 11.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Section 352.03, Subdivision 4, as added by Laws 1963, Chapter 383, Section 11, is amended to read:

Subd. 4. **State employees retirement; fund officials.** The board shall elect a chairman and *shall* appoint ~~a~~ *an executive secretary and assistant secretary*, and ~~such~~ other employees as may be necessary; ~~including~~ and shall contract for actuarial services, professional management services and consulting services as may be necessary, and fix ~~their~~ the compensation therefor. Such contracts shall not be subject to the competitive bidding procedure prescribed by Minnesota Statutes, Chapter 16.

*Appointment of the executive secretary and assistant secretary shall be in the unclassified service but appointees may be selected from civil service lists should the trustees desire to do so. The compensation of the employees in the unclassified service shall be fixed by the trustees who shall have full and exclusive authority regarding such compensation notwithstanding the provisions of section 350.083. Professional management services may not be contracted for more often than once in every six years. Copies of all professional management survey reports shall be sent directly to the legislature and the public examiner at the same time reports are furnished the trustees. Only management firms experienced in conducting management surveys of federal, state or local public retirement systems shall be qualified to contract with the trustees hereunder.*

*The board may provide in-service training for all employees of the association.*

*training of workers with the blind; amending Minnesota Statutes 1961, Section 248.07 by adding a subdivision thereto.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Section 248.07 is amended by adding a subdivision thereto to read:

*Subd. 14. Blind; training of workers for rehabilitation of blind. From funds provided by the State or the United States for the rehabilitation of blind persons, the commissioner of public welfare may make provision for:*

(1) *Specialized supplementary training of professional workers employed by services for the blind, which shall consist of selected courses of study designed to improve worker techniques in providing assistance with adjustment to blindness, guidance, training and vocational placement services to blind children and adults;*

(2) *The employment of student trainees enrolled in graduate school programs. Such trainees to be employed on a one-third time basis during the regular school term and on a full time basis during the extra school term. Student trainees shall not be counted against the regular staff complement and shall not exceed four in number employed concurrently.*

CHAPTER 693—H. F. No. 1912

*An act relating to tort liability of the city of Saint Paul; providing for self insurance and method of financing for such liability.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **St. Paul, city of; tort liability; insurance.** The governing body of the city of Saint Paul may self insure against liability of the municipality and its officers, employees, agents and servants for damages resulting from its torts and those of its officers, agents, servants and employees, including torts specified in Laws 1963, Chapter 798, Section 3 for which the municipality is immune from liability; such self insurance may be used for affording protection in excess of liability imposed by Laws 1963, Chapter 798, Section 4.
