- Sec. 2. EMERGENCY BORROWING. To meet a public emergency affecting life, health, property or the public peace, and to the extent that there are no available unappropriated revenues to meet such emergencies, the board may, by unanimous vote, authorize the issuance of emergency notes. These notes may be renewed from time to time but the emergency notes and renewals of any fiscal year shall be paid not later than the last day of the fiscal year next succeeding that in which the emergency appropriation was made. The issuance and payment of these notes is subject to the mill limits on taxing power established by law for Ramsey county.
- Sec. 3. TRANSFER OF APPROPRIATIONS. The Ramsey county board may during 1971 and thereafter by resolution transfer part or all of any unencumbered appropriation balance or unappropriated funds from one department, office or fund to another department, office or fund.
- Sec. 4. APPROVAL AND COMPLIANCE. This act shall take effect upon its approval by the Ramsey county board of commissioners and upon compliance with Minnesota Statutes, Section 645.021.

Section 1. RAMSEY COUNTY; COMMISSIONER DISTRICTS. That the commissioner districts of Ramsey county be and the same are hereby declared to consist of the following territory: Commissioner district number one (1) shall consist of the townships of Rose and Mounds View and the village of New Brighton, and shall elect one (1) commissioner; and commissioner district number two (2) shall consist of the townships of New Canada and White Bear and the villages of White Bear and North St. Paul, and shall elect one (1) commissioner; Commissioner district number one (1) shall consist of

all of Ramsey county located outside the corporate limits of the city of Saint Paul and west of the centerline of Rice Street, except the corporate village of North Oaks shall not be within commissioner district number one (1), and shall elect one (1) commissioner; commissioner district number two (2) shall consist of all of Ramsey county located outside of the corporate limits of the city of Saint Paul and east of the centerline of Rice Street, except that the corporate village of North Oaks shall be completely within commissioner district number two (2), and shall elect one (1) commissioner; and commissioner district number three (3) shall consist of the city of St. Paul, and shall elect four (4) commissioners.

Sec. 2. This act shall take effect upon its approval by the board of county commissioners of Ramsey county and upon compliance with Minnesota Statutes, Section 645.021.
