CHAPTER 68-H.F.No.31

An act relating to elections; providing for the use of voter registration systems in school elections; amending Minnesota Statutes 1969, Section 201.33.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1969, Section 201.33, is amended to read:

201.33 ELECTIONS; SCHOOL DISTRICTS; VOTER REGISTRATION. Upon the request of the board of education of any independent or special school district the commissioner of registration of any municipality shall make the registration system covering any precincts all or a portion of which are a part of the school district available for use in school district elections whenever its use by the school district will not prevent the use of the system in other elections. The commissioner may impose reasonable requirements to preserve the security and integrity of the system. The commissioner and the school district shall provide by agreement for the details of the use of the system by the school district. The school district may designate a member of its board or a subordinate employee as registration officer. The provision of section 201.16, shall apply to school district elections in which the provisions of this section are applied. The judges of election in school district elections in which the provisions of this section are applied, may not receive the vote of any person whose name is not registered, except as is provided in section 204.075.

Sec. 2. This act takes effect upon its final enactment.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1969, Chapter 525, is amended by adding a section to read:

[525.805] PROBATE PROCEEDINGS; NONRESIDENT REPRESENTATIVE; AGENT FOR SERVICE OF PROCESS. Every individual appointed a representative under the provisions of this chapter who resides without this state shall before entering upon the duties of his trust in writing appoint and continuously maintain a competent person who is a resident of this state as his agent for service of process. Such writing shall contain the complete and accurate residence address of such agent and shall be filed with the court. Thereupon letters may issue and thereafter all service of process may be made upon such agent with the same force and effect as if made upon said representative personally within this state.

Sec. 2. EFFECTIVE DATE. This act is effective October 1, 1971.

CHAPTER 70—H.F.No.247

An act relating to the blind; rights as pedestrians and in connection with housing accommodations; providing a penalty; amending Minnesota Statutes 1969, Chapter 256C, by adding a Section; and Sections 169.202, Subdivision 2; 256C.01; 256C.03; 256C.05; and 256C.06.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1969, Chapter 256C, is amended by adding a section to read:

[256C.025] BLIND PERSONS; HOUSING; PROTECTION AS PEDESTRIANS. Subdivision 1. Blind persons, visually handicapped persons, and other physically disabled persons shall be entitled to full and equal access, as other members of the general public, to all housing accommodations offered for rent, lease, or compensation, subject to the conditions and limitations established by law and applicable alike to all persons.

Subd. 2. "Housing accommodations" means any real property, or portion thereof, which is used or occupied or is intended, arranged, or designed to be used or occupied, as the home, residence or sleeping
