Any city of the first class now or hereafter having a population of 450,000, or over, or its board of park commissioners, which has acquired tax-forfeited land for a specified public use pursuant to the terms of this section, may convey said land in exchange for other land of substantially equal worth located in said city of the first class, provided that the land conveyed to said city of the first class now or hereafter having a population of 450,000, or over, or its board of park commissioners, in exchange shall be subject to the public use and reversionary provisions of this section; the tax-forfeited land so conveyed shall thereafter be free and discharged from the public use and reversionary provisions of this section, provided that said exchange shall in no way affect the mineral or mineral rights of the state of Minnesota, if any, in the lands so exchanged.

CHAPTER 444 — H.F.No. 1656

An act relating to commerce; motor fuel franchises; providing for a temporary prohibition on certain building alterations that eliminate service bays.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. DEFINITIONS.

Subdivision 1. TERMS. As used in this act, the terms defined in this section have the meanings given them.

- Subd. 2. FULL-SERVICE STATION. "Full-service station" means any place of business where motor vehicle fuel is sold and delivered into the tanks of motor vehicles and has an enclosed area where automobile repairs are offered to consumers, including, but not limited to, lubrication, oil change, tire repair, battery charge, replacement of fan belts, hoses, and wiper blades.
- Subd. 3. SERVICE BAYS. "Service bays" are enclosed areas where automobile repairs are performed, including, but not limited to, lubrication, oil change, tire repair, battery charge, replacement of fan belts, hoses, and wiper blades.

Sec. 2. ELIMINATION OF SERVICE BAYS PROHIBITED.

<u>Subdivision 1.</u> **BUILDING ALTERATIONS.** <u>No motor fuel franchisor</u> shall alter a full-service station building for the purpose of eliminating the service

bays unless the motor fuel franchisee operating the full-service station consents in writing to the alterations.

Subd. 2. LIMITATION. Nothing in this section prohibits a motor fuel franchisor from altering a full-service station that is not operated by a franchisee.

Sec. 3. ENFORCEMENT.

The attorney general or any aggrieved party may institute a civil action in the district court for an injunction prohibiting any violation of section 2. It shall be no defense to such an action that the state or aggrieved party may have adequate remedies at law.

Sec. 4. REPEALER.

This act is repealed on July 1, 1986.

Sec. 5. EFFECTIVE DATE.

This act is effective the day following final enactment.

CHAPTER 445 — H.F.No. 1651

An act relating to crimes; including conservation officers as peace officers authorized to enforce the crime of fleeing a peace officer and related laws; setting penalties for flight from a peace officer under certain conditions; amending Minnesota Statutes 1982, sections 65B.605, subdivision 2; and 609.487, subdivisions 2 and 4.
