CHAPTER 271-H.F.No. 2239

An act relating to local government; allowing the city of Morristown to maintain and pay for certain electrical power outside the city.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. MORRISTOWN; ELECTRICAL POWER OUTSIDE CITY.

Notwithstanding other law, the city of Morristown may maintain and pay for electrical power for street or highway lighting at the intersections of highway 60 and highway 16 and highway 60 and highway 44 and the environs of both of those intersections.

Sec. 2. EFFECTIVE DATE.

CHAPTER 272-S.F.No. 1946

An act relating to highways; designating POW/MIA Memorial Highway, Veterans Memorial Highway, and John Riley Memorial Drive; amending Minnesota Statutes 1994, section 161.14, by adding subdivisions.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 1994, section 161.14, is amended by adding a subdivision to read:

Subd. 33. POW/MIA MEMORIAL HIGHWAY. Trunk highway marked No. 169 from its intersection with trunk highway marked No. 10 in or near the city of Elk River to its intersection with state highway marked No. 18 in or near the city of Garrison and state highway marked No. 18 from its intersection with trunk highway marked No. 169 in or near Garrison to its intersection with trunk highway marked No. 371 in or near the city of Brainerd is designated the "POW/MIA Memorial Highway." The commissioner of transportation shall adopt a suitable marking design to mark this highway and shall erect the appropriate signs. The people of the community, having resolved to support and financially back the marking of this highway, shall reimburse the department for costs incurred in marking and memorializing this highway.

Sec. 2. Minnesota Statutes 1994, section 161.14, is amended by adding a subdivision to read:

Subd. 34. VETERANS MEMORIAL HIGHWAY. Legislative route No. 131, marked as trunk highway No. 115, is designated the "Veterans Memorial Highway." The commissioner of transportation shall adopt a suitable marking design to mark this high-

CHAPTER 273-H.F.No. 1926

An act relating to occupations; regulating the practice of dental hygiene; amending Minnesota Statutes 1994, sections 150A.05; 150A.06, subdivision 2; and 150A.10, subdivision 1.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 1994, section 150A.05, is amended to read:

150A.05 LICENSED DENTAL PRACTICE OF DENTISTRY.

Subdivision 1. **DEFINITION PRACTICE OF DENTISTRY.** A person shall be deemed to be practicing dentistry within the meaning of sections 150A.01 to 150A.12:

(1) who uses a dental degree, or designation, or card, device, directory, sign, or other media whereby the person represents an ability to diagnose, treat, prescribe, or operate for any disease, pain, deformity, deficiency, injury, or physical condition of the human tooth, teeth, alveolar process, gums or jaw, or adjacent or associated structures; or

(2) who is a manager, proprietor, operator or conductor of a place where dental operations are performed; of

(3) who performs dental operations of any kind gratuitously, or for a fee, gift, compensation or reward, paid or to be paid, to any person or agency; Θ

(4) who uses a roentgen or X-ray machine for dental treatment, roentgenograms or for dental diagnostic purposes; or

(5) who extracts a human tooth or teeth, or corrects or attempts to correct malpositions of the human teeth or jaws; Θ [±]

(6) who offers and undertakes, by any means or method, to diagnose, treat or remove stains or accretions from human teeth or jaws; eff
