- Section 1. Minnesota Statutes 2018, section 363A.03, subdivision 43, is amended to read:
- Subd. 43. Sexual harassment. (a) "Sexual harassment" includes unwelcome sexual 1.6 advances, requests for sexual favors, sexually motivated physical contact or other verbal or 1.7 physical conduct or communication of a sexual nature when: 1.8
  - (1) submission to that conduct or communication is made a term or condition, either explicitly or implicitly, of obtaining employment, public accommodations or public services, education, or housing;
  - (2) submission to or rejection of that conduct or communication by an individual is used as a factor in decisions affecting that individual's employment, public accommodations or public services, education, or housing; or
  - (3) that conduct or communication has the purpose or effect of substantially interfering with an individual's employment, public accommodations or public services, education, or housing, or creating an intimidating, hostile, or materially offensive employment, public accommodations, public services, educational, or housing environment.
- (b) Paragraph (a), clause (3), does not require the harassing conduct or communication 1.19 to be severe or pervasive. Conduct or communication has the purpose or effect of creating 1.20 an intimidating, hostile, or materially offensive environment when: 1.21
