BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: 1.4 Section 1. COMPREHENSIVE STATEWIDE SUSTAINABLE WATER 1.5 RESOURCES DETAILED FRAMEWORK. 1.6 1.7 (a) \$750,000 in fiscal year 2010 is appropriated from the clean water fund to the University of Minnesota for the development of a comprehensive statewide sustainable 18 water resources detailed framework to protect, conserve, and enhance the quantity and 1.9 quality of the state's ground and surface waters. The detailed framework shall be a 1 10 long-range, 25-year detailed framework, with an implementation schedule and associated 1 11 benchmarks, for policy, research, monitoring, and evaluation in order to achieve 1.12 sustainable ground and surface water use, including the ecological benefits provided by 1.13 water resources to humans and fish and wildlife habitat. For the purposes of the detailed 1 14 framework, water use is sustainable when the use does not harm ecosystems, degrade 1.15 water quality, or compromise the ability of future generations to meet their own needs. 1.16 (b) The detailed framework shall be developed by the University of Minnesota Water 1 17 Resources Center in cooperation with federal, state, and local government and private 1 18 nonprofits with expertise in water resources. In developing the detailed framework, the 1.19 water resources plans of organizations with water resources expertise shall be considered. 1.20 The detailed framework must include, but is not limited to, identification of infrastructure 1.21 needs, drinking water, ground and surface waters, storm water, agricultural and industrial 1.22 needs, the interfaces of climate change, development and land use, and demographics. 1.23
